KAP WR 12/18/87: Don Laderoute (card), owner of 3-D Landscaping, was in for information on assessment work. He is also part owner of 3-D Mining Co (card) 3-D Mining Company has a material sale contract from the BLM to mine "Mossy" basalt boulders from a portion of the SE 1/4 Sec 20, T14N R11W, Mohave County. He hauled out slightly over 100 tons in 1987 for which he paid the BLM. He originally had located the property with 4 claims, the Cayou #1 through #4, but he had to relinquish the claims to obtain the material sale. He calls the mine the 3-D, Cayou is an aka. He had hoped we would have included his operation in our Directory of Active Mines, but we had no specific knowledge of his operation. He hopes to sell considerably more of the lichen covered boulders for landscaping in 1988. He claims the lichen is up to 1 inch thick and multi-colored and makes the boulders very distinctive. He said the 100 tons he has mined so far was done with very little visible surface disturbance.
