Western Helium Corp. has taken over Arizona Helium Corp. plant at Navajo. FTJ Quarterly
Report 1-13-71

Information from Mr. Allen of Oil & Gas Commission:

Air Reduction put a portable helium extraction plant at its Texas well at Teec Nos Pos in April 1968 and operated it until December 1969—not operated since.

Arizona Helium plant at Navajo, according to Pay Dirt, started operating in February, 1968, but a Phoenix Gazette article of 5/27/69 said Arizona Helium's first shipment from the plant had just been made. The plant closed before the end of 1969 and the company went into bankruptcy. Western Helium Corp. leased the plant in 1970 and purchased it at auction on July 15, 1971. Western ran the plant under lease for about four months. The Western Corporation reorganized and was due to resume operation May 8, 1972.

KAP WR 11/18/83: Ken Zarp, Valley National Bank trust department, requested information on Arizona Helium Corporation. He has a trust which includes some stock. He reported that according to the Arizona Oil and Gas Conservation Commission, the property and firm are not operating and their lease has expired.
