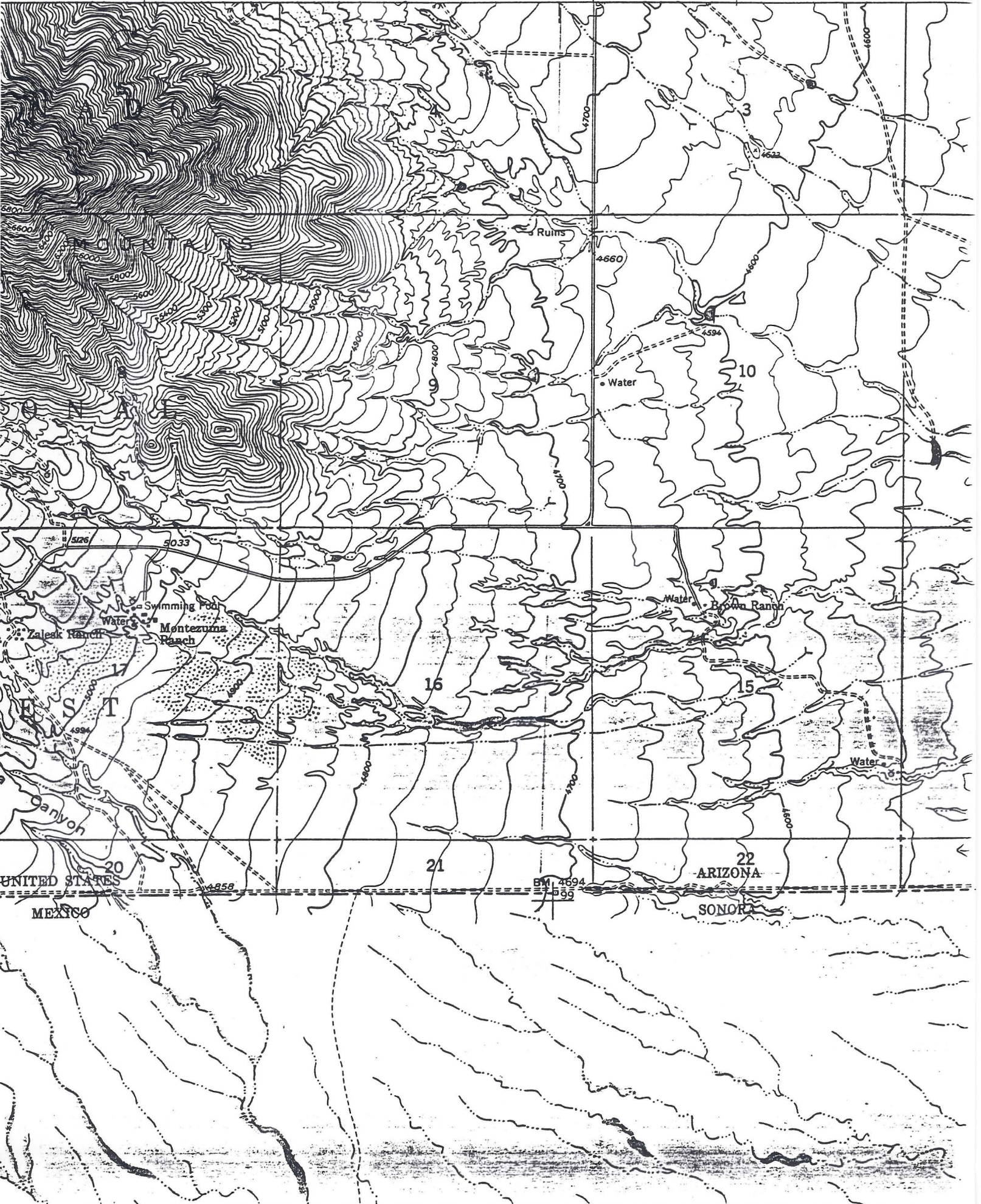

FIELD ENGINEERS REPORT

Mine ' Bell Claim Date June 17, 1960  
District Hartford (Huachuca) Dist., Cochise Co. Engineer Axel L. Johnson  
Subject: Field Engineers Report. Information from A. B. Capt & personal visit.

Location: Sec. 5 - T. 24 S. - R. 21 E. About 24 miles east of Bisbee. Drive on Highway No. 92 for 23 miles east of Bisbee. Turn left and drive an additional mile to the claim.

Number of claims: 1 unpatented claim, re-application for patent made 6 months ago.

Owners: ' A.B. Capt and Ursula Capt, Box 3083, Lowell, Arizona

Principal Minerals: ' Silver, gold, copper.

Present Mining Activity: Exploration work in open cut. Part time work by owner.

Geology: Country rock is a metamorphic rock, resembling quartzite, which has been intensively hydrothermally altered and contains a considerable amount of sericite and calcite. A considerable amount of pyrite is also disseminated throughout the rock. Rock also contains a few narrow quartz stringers, which contain a small amount of chalcopyrite, and may also contain some gold and silver values.

Ore Values: No samples have been taken in the cut. No commercial ore is, as yet, indicated.

Past History: Claim was located in 1929. Surveyed for patent in 1955, and application for patent was turned down. Owner paid taxes on the property from 1955 to 1959. Owner has now made re-application for patent. Bob Lenon, mineral surveyor, Mr. Gentry, attorney.

Mine Workings: Open cut about 50 ft. long, 12 ft. wide and from 0 to 20 ft. deep, being 20 ft. deep at face of cut.

Review of Recent Operations: Mr. Capt has been working the above open cut intermittently, bringing in an air compressor, a drill and a couple of men to drill and blast, and later mucking out the material himself.

Proposed Plans: Mr. Capt plans to start an incline shaft from the face of the open cut. He hopes to find commercial ore, or good ore showings, which would be used to substantiate his claims for a patent on the mining claim.

Additional: Mr. Capt wishes to have field engineer examine the Peggy claim later on, on which patent was also turned down previously and on which a re-application for patent has been made. This claim is further up the mountain and Mr. Capt will provide riding horses for the trip.
