Feb. 19, 1962 - A visit from A. A. Anderson, 7445 Joshua View, Yucca Valley, Calif. and Val' Boldizer, his associate, also of California, re iron in the Planet-Bouse region. As the Anderson Mining Company he has taken up iron bearing ground at various places in the region and has obtained options on others including the patented Planet claims of the New Planet Mining Co. He has a 300,000 ton Japanese contract and shipped recently (13 cars) from the Black Rock deposit east of McVay.

TRAVIS P. LANE - Weekly Report - Feb. 24, 1962.

Abstract from "Arizona Iron Ore Deposits" in IRON COMMODITY file: The Black Hawk and King Deposits are near and east of McVay, west of Salome. According to B.J. Carpenter, the Black Hawk deposit consists of "dikes" containing 60 percent iron. The "dikes" are narrow (up to 8 feet wide) and dip 40° . The King is similar to the Black Hawk and is up to 4 feet thick. (Anderson Mining Co., Box 333, Bouse, Arizona.)

The Iron Duke deposit is 8 miles south of Bouse. It has 3 dikes, 30 to 40 feet wide and dipping 40° and containing red hematite. They run about 50 percent iron according to B.J. Carpenter, Supt. Anderson Mining Company, Box 333, Bouse, Arizona.

Subject: Negotiations on Iron properties

A. A. Anderson as the Anderson Mining Co., ^{7445 JOSHUA VIEW, YUCCA VALLEY, CALIF.} ~~600 E. Bay Street, Balboa, Calif.~~ has gathered together several groups of iron claims and has negotiated with groups of engineers representing Japanese firms re shipment of iron ore to Japan. Val Boldizar is associated with Anderson. The following notes concern Mr. Anderson's activities in this regard in the Planet Peak-Bouse region. Foster Sott, resident of Bouse was the source of much of the information.

Oct. 16, 1959 - Interviewed at Bouse, B. J. Carpenter, Supt. for Anderson Mining Co., Box 333, Bouse, Arizona. Mr. A. A. Anderson is the president of the company and directs its activity. The company has 2 iron properties, the Black Hawk and the King, near and east of McVay, and another, the Iron Duke, some 8 miles southwest of Bouse. Also, the company has the Planet mine, in the Planet district under contract.

Mr. Carpenter describes the McVay deposits as being dikes containing above 60% iron in the form of mixed hematite and magnetite at the Black Hawk (8 feet thick), and all magnetite at the King (4 feet thick), both dipping about 40°. The Iron Duke property contains 3 dikes from 30' to 40' thick with about 50% iron content in the form of a deep red hematite. The dikes dip about 40°.

A crew has been occupied for some time building roads, doing location work, stripping for samples, etc. At the time of visit Mr. Carpenter was the only employee. He states that negotiations have been under way for some time with Japanese firms and that 8 separate visits have been made by Japanese engineers representing as many steel companies. He reports that Anderson anticipates closing contracts with the Japanese within the near future. James O. Rhude of Minnesota may contract the mining and also the construction of a beneficiation plant (if and when needed on the Iron Duke property). The goal is a production of 1 million tons a year, and Mr. Anderson reportedly expects to reach this rate within a year.

May 17, 1961 - Several persons at Bouse spoke of A.A. Anderson showing them a contract recently signed by a Japanese group for delivery to Japan of 300,000 tons of iron ore. Specifications, prices etc were not available.
