NJN 1/26/83: B00MER Claims owned by Pathfinder Mines. They are located in T11N R11W Sec. 17, 18, 20, 21, 26, 27, 28, 29, 30, 32, 34, and 35. There are 270 claims. Case of property entry appears to be in Sections 28 and 29 and this was the area of dispute in the court case. See The Public Land and Resources Law Digest, 1981, no. 1, page 127, the case of Geomet Exploration Ltd. v. Lucky Mc Uranium Corp. Lucky Mc is now Pathfinder Mines.

NJN WR 1/21/83: With help from CLiff Hicks of the Tucson office, traced down the uranium property that was the subject of the Arizona Supreme Court decision, Geomet VS Lucky Mc. The property is in the Date Creek Basin of the Artillery Peak Range, in Yuma County. The property is now mostly held by Pathfinder mines, previously known as Lucky Mc. A new file, the Boomer Claims, now contains the **pertinent d**ata and references on the property.
