Location: Adjoins the old Dutchman mine (famous for "secondary enriched" gold ore) on the northwest.


Work: This and some other ground (presumably on the Dutchman) was drilled 2 years ago, by the Simplot Co. Several holes were sunk that had good core results hampered by very heavy water flow. (Evidently they did not get satisfactory results, since they did not return).
