Present Status Idle.

On my visit to the property on Sept. 18, I found a diamond drill rig had been hauled in and ready to start operations.

On my visit to the area on Oct. 30, I was informed that the company had put down one diamond drill hole to a depth of 100 at a reported cost of \$12,000, and then took the drill away.

During telephone conversation with Harry Oswalt of the Southwest Mining Industries on Nov. 2, I was informed by Mr. Oswalt that exploration work with additional diamond drilling will be continued as soon as they can find an experienced diamond drill man to conduct the work.
