Location Near Bernardino, about 27 miles NE of Douglas, and near Hwy. # 80.

Number of Claims 12, (or possibly more), claims on State land, covered by State leases. Operations, at present, confined to only two of the claims.

Principal Materials 'Cinder and Scoria

<u>Present Activity</u> Excavating cinder and scoria, and loading same in trucks for transportation to Douglas, where it is loaded in Ry. cars for shipment to Tucson. Before the S. P. Ry, from Douglas to Columbus, N. Mex, was discontinued, the material was loaded at the San Berardino Ry. siding, and then shipped from there by railroad to Tucson. Now, it is necessary to truck the material to Douglas for shipment. Production is about 100 tons per day. 3 men are working -- 5 days per week.

Uses Material is used by San Xavier Materials, Inc. in the manufacture of concrete blocks and other products.
