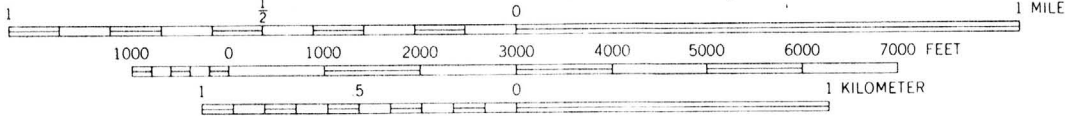

Dalton Robinette
Has/31 claims in Devil's Canyon, T17N, R14W in Maynard District optioned to Clyde Simpson & W. W. Bearfoot, Albuquerque, New Mexico. FTJ WR 1-7-66

Visited Dalton Robinette whose claims in Devil's Canyon, Sec. 14, T15N, R14W are under option to Arkla. FTJ WR 1-5-68

Visited Dalton Robinette's place - No one home. FTJ WR 3-8-68

Visited Robinette - said he was still being paid by Arkla on option agreement. FTJ WR 3-7-69

Inland Copper Co. of Vancouver located about 35 claims in Devil's Canyon adjoining Robinette's claims that they have been drilling. FTJ WR 5-10-71

To Robinette's - who said Inland Copper Co. of Canada had option on his claims; also claims of Thermo-Chem Co. (Breneda) also of Canada. Inland said to have drilled 60' of .4% Cu also MOS_2 and were continuing exploration. FTJ WR 5-10-71

There are no reports of activity by the Inland Copper Company Ltd., Vancouver, B. C., on the Robinette claims southeast of Yucca. GW QR 2/72

Mr. Robinette said Inland Copper Mining Company, Vancouver, B.C. had dropped his Cu claims in Devils Basin southeast of Kingman but that two local major companies had looked at them, one of whom will do some additional exploration. GW WR 4/5/72

Mr. Robinette of Kingman is sinking 4 - 30 ft. shafts 500-1,000 feet apart on his moly claims (32) adjoining the old Leviathan mine. GW WR 9/6/72
