LOCATION:

The group consists of some 18 unpatented claims situated some 6 miles south southeast of the Castle Dome mining district in Yuma County. Specifically, it is situated in Section 5 South and along Range line 13 and 19 West.

GEOLOGY:


The claims are elongated in a general north and south direction. They are underlain mainly by greenish chloritic schists that strike east and west and dip steeply at 80 degrees to the south. These probably represent altered andesitic volcanic rocks and are generally unmineralized. A narrow zone, in places up to 20 feet wide is mineralized with secondary copper. This latter zone is associated with and undoubtedly directly related to a north and south oriented quartz wein that cuts through the volcanic rocks. Weathering of the quartz has spread copper precipitation into the adjacent schists.

SAMPLING:

No samples were collected for assaying because of the fact that, despite any copper values obtained, it was obvious from the surface examination the mineralization was limited.

CONCLUSIONS:

No further consideration should be given to this property.
