This property consists of two mining claims and is located in upper Castle Creek and 36 miles from Morristown, or approximately 18 miles east of Wickenburg. It is about $3 / 4$ mile from the Whipsaw mine.
Principal metal: Copper.
Present operation consists of just what the owner can do himself in shallow pits, or shafts. He would like to go into productions on a larger scale, but he says, he has to throw too much of his ore over the dump, as the cost of hauling out over the present roads is so high he can't move the main part of his ore. When there is a shorter and better road, he thinks he can easily produce 15 to 20 tons ore per day. He has now $14 \%$ copper ore ready to haul out, 15 tons of it.

Geology: The geology is the regular Bradshaw Granites, with Diorites and Schist. There are two veins, 2 feet thick with a strike North-South.

Water: The property is only off $\frac{1}{4}$ mile from Castle Creek, so water for mining can be had from there.

Roads: At the present time travel is down Castle Creek wash to the Hot Spring road and into Morristown, which is tough going.

With $\frac{1}{2}$ mile road this property can be connected up with the Whipsaw mine and connect with very little work with the proposed Road from the Wickenburg side, which pass by the Copper State mine, or Swallow mine.
