MEMORANDUM

SUBJECT: Small Lot Shipment
Tungsten

TO: W. C. Broadgate

FROM: J. S. Coupal

Mr. R. A. Bernie, Sahuarita, Arizona, has just phoned that he has ten tons of 1% plus tungsten ore which he trucked from his property, the Copper World Claim of the Helvetia Mining and Milling Company located at Helvetia, in Phoenix awaiting permit to deliver to the small stockpile.

He was misinformed that no contract or rating as eligible or otherwise on the tungsten shipments was necessary, but acceptance of his ore by the stockpile is held up pending his formal contract or permit as an eligible producer.

Mr. Bernie stated that he was just on his way to Tucson and will forward to you tonight by airmail the necessary form filled out so as to allow the stockpile to receive his ore. I asked Bernie to forward this to you so that you may follow it up and get as quick action as possible.
