

Many thanks for your letter of January 5 and I note what you say about the proposed work on the Dogwater tunnel.

I will mention the fact, however, that a number of applications for "C" loans have been rejected where there was such a small amount of water as 20 feet in a shallow winze. The RFC Mine Loan Division feel as though work of that type not calling for any appreciable expenditure should be done by the owner rather than by a loan. I simply state this so that you may be prepared to know just how applications are received.

We have appointed Andrew Macfarlane as engineer for the Eastern District. He is now engaged on an asbestos survey which should be completed with in the next few days and we will than assign him to the regular field engineer's work in the Eastern District.

Dear Mr. Bott:

Your letter of December 7 received and am glad to hear that you are contacting parties for additional information.

You can use the Verity report on either a "B" loan or "C" loan. I can see no harm in including in your application the cost you have been to in getting the report.

Regarding your questions, I find, from a rough tabulation, that from 1940 up until November 1, 1942 there were 156 "B" loan applications made. Of these, 72 were rejected, 22 approved, and 62 held pending further decision. This tabulation does not show the reasons for rejection. I do know, however, that the main reason for rejection is insufficient data to justify the loan, or data which is not conclusive enough to warrant the granting of a loan.

As I explained to you in my letter and in our conversation at Klondyke, I question the wisdom of making an application for a "C" loan on your property. The only reason you would have for asking for a "C" loan would be to clean out the underhand stope in the tunnel, which, from your figures and from the figures given by Mr. Verity, would be approximately 30 feet in length, 5 feet wide, and not to exceed 6 feet below the tunnel track. This roughly figures 900 cubic feet or between 50 or 60 tons of material.

This should not cost more than \$3 a ton to remove, and I doubt very much if a "C" loan would be granted to do this work and by this work expose the ore showing at the bottom of the underhand stope which would be the determining factor in a loan.

This is only my suggestion and you may feel as though you should apply for a "C" loan and if you feel that way there is nothing to prevent

My best suggestion would be that you clean out the underhand stope, then sample the ore, have the assays indicated on a map where the assays were taken, and make an application for a "B" loan. Dear George:

I have your letter of November 20 and from it, I judge you feel a little perturbed at our being unable to give you more direct assistance.

Fortunately, Mr. Victor Verity called at the office today and I took occasion to discuss with him in detail your problem, and as he has seen the property and has gone over it, I believe from his description, I can be of as much service to you by letter as though I had been on the property.

We discussed the ore showing on the Silver Cable Claim and from his investigations, I cannot recommend expenditure of time or labor on that property for immediate results. His feeling on the Dogwater Claim is the same as I gathered from your report and from my discussions with you. You could, of course, apply for a "C" loan in order to clean out the muck in the underhand stope and make this stope available for careful sampling and then find whether or not a "B" loan would be granted for further development of the ore exposed in this underhand stope. However, if we assume the stope to be five feet in width, six feet deep, and approximately thirty feet in length, it would mean approximately fifty tons of muck which should be removed, in order not to cost more than \$2.50 a ton to muck this out and expose the ore at the bottom of the underhand stope.

I doubt very much if a "C" loan would be approved for this small amount of work, and for that reason, my advice to you is to clean the shallow underhand stope from muck so as to expose the vein and then sample the vein and determine at that time whether or not the showing was sufficiently good to warrant making an application for a straight development or "B" loan.

It is up to you to make up your mind which course you wish to pursue, and I am merely expressing my judgment when I say that I doubt if a "C" loan would be favorably considered for the small amount of work necessary.

If when the stope is cleaned out and a good showing is exposed, you could then safely apply for a "B" loan.

I hope that my reply to your letter will enable you to decide which procedure you care to follow; that is, to make a "C" loan with the probability of its being turned down, or to prepare the stope on your own expense for making a "B" loan application.

November 12, 1942 Mr. George Bott Willcox, Arizona Dear George: On my return to the office, I find the report on your Silver Cable, Dogwater, and Mountain Springs Mines. I believe I explained to you the work that I think should be done on the underhand stope in the Dogwater Tunnel, that is, the cleaning out of the muck and a sampling of the ore at the bottom of the undercut stope. With this work done and a favorable showing, you could consider an application for a development loan. I doubt very much if, under the conditions you described, you would be able to qualify the Dogwater Tunnel development under one of the "C" loans. On my return to the office, I received word that Mr. Fred Perkins, our engineer, passed away on Saturday night, November 7.
