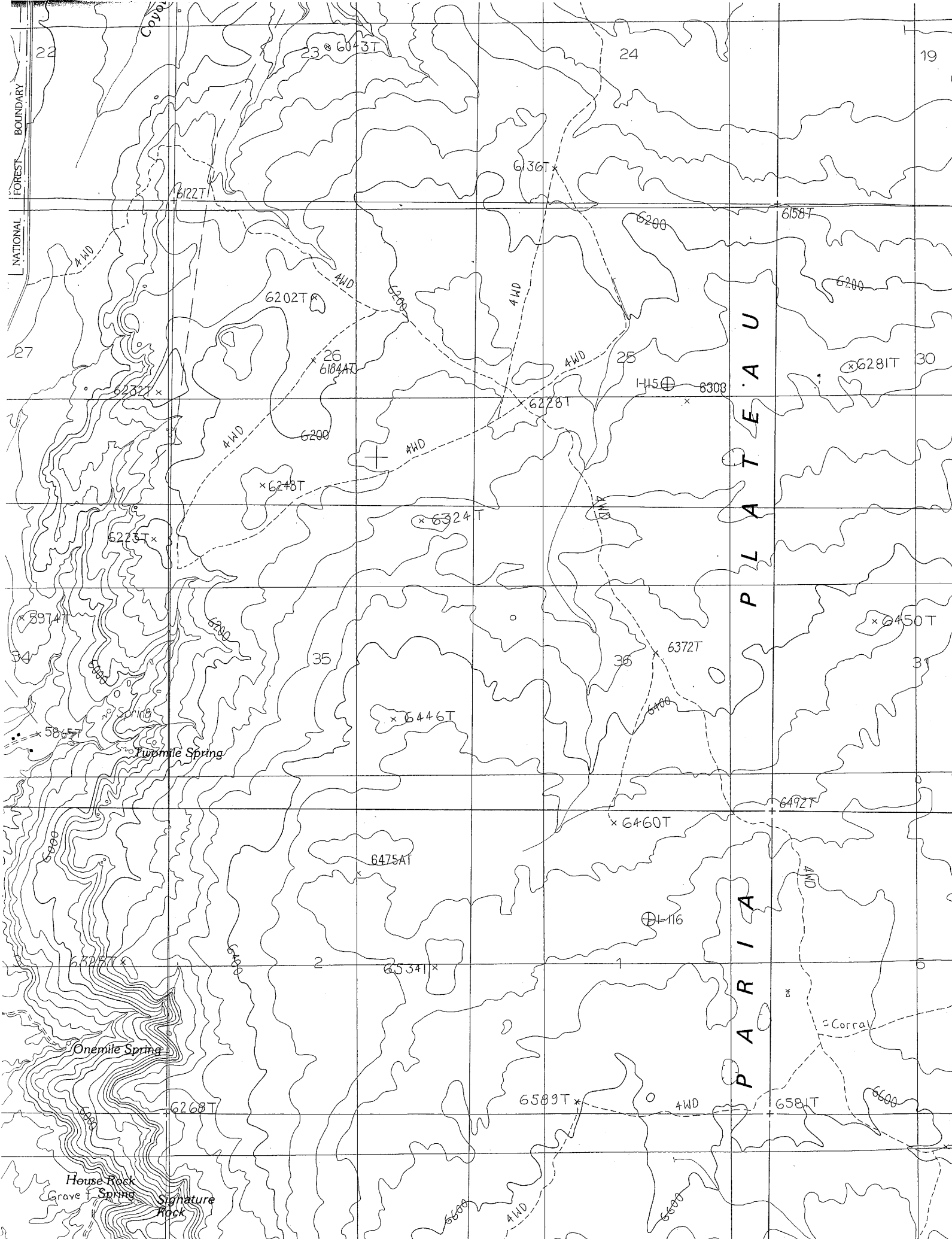

During a visit to the property Mr. Rabinoff and some members of BLM's St. George office took about 15 samples of Navajo Sandstone. No evidence of mineralization was observed, only ordinary eolian sandstone. Assay results from Arizona Testing Laboratory were nil and trace. No written report of their visit is available.


Mr. Golexis was in and explained his interest in the property as a possible low cost gold producer if the gold content of the sandstone could be verified and if a deposit could be delineated.

Although he admitted no mining experience, he felt his business experience had some value. He has taken an initial 26 samples from the property and sent them to OMAC Systems in Tempe and Rocky Mountain Geochemical in Salt Lake City. Most of the OMAC samples ran some gold (0.002 - 0.054 tr oz Au/ton with 11 samples being reported "Nil") while all of Rocky Mountain's results were "none detected" (less than 0.001 Au and less than 0.01 Ag).

It was suggested that he obtain the pulps from Rocky Mountain Geochem and have them run by OMAC. Also, he should obtain the pulps from OMAC, divide them and have a split run by Rocky Mountain, a split run by Jacobs Assay in Tucson and a repackaged, renumbered split run by OMAC. If OMAC is the only lab to report gold, they should then be presented with all the results and asked for an explanation.

Until the assay result inconsistency problem is resolved, no further work should be committed to the property.

NJN WR 8/28/87: John Rich, of Jacobs Lake, reported that he has been finding gold in a sandstone, possibly the Navajo. He reported finding the gold in the basal portions, sometimes in quantities of up to .1 oz. This is in the area of T39N R3E Sec 36.

---

KAP WR 9/4/87: John P. Rich asked for help in getting the BLM to release a withdrawal on the S $\frac{1}{2}$  Sec 2 T39N R3E. He explained that the withdrawal was due to the application by the Navajo Tribe to acquire the land as part of their reservation. Since the application by the Navajoes has long been dropped, he felt the withdrawal should be lifted. He believes he has discovered economic quantities of gold in the area and would like to locate claims on his discovery.

NJN WR 6/3/88: Chris Glade of Big Red Gold, Inc, a Utah corporation, Phoenix address, 2450 E. Jackson, Phx, AZ 85034, 231-8867 or 231-8868, visited and reported that Big Red Gold was interested in obtaining information regarding permitting prior to developing their Dorothy Gold (file) Coconino County. By surface sampling he reported that company has identified 10 million tons of 0.333 oz/ton Au. Based on sketchy geological information and surface sampling, no drilling, and the use of numerous unregistered assayers, this occurrence and the estimated reserves in the Navajo Sandstone on the Paria Plateau, is unlikely.

NJN WR 7/15/88: John Branch, BLM geologist, Arizona Strip Office, reported that preliminary analysis of samples taken from the Dorothy Gold (file) Coconino Co had the following values: 0.12 ppm and 0.08 ppm for gold. He reports that another visit will be made to the property.
