Works at a body shop in Tucson and at his mine on Saturdays and Sundays.

The Mine is located in Sections 5 & 6 R15E T10S and over into Sec.1 R14E T10S.
There are three claims, part or all of which are leased from the State.
The Little Hill Mines adjoin the Falcon J. on the east.

A vertical shaft reported to be 100 to 110 feet deep equipped with a small steel headframe, a sheet iron hoist house equipped with an electric hoist.

Some oxide copper stains can be seen in the dump rock which is close to the headframe.

Visited Falcon J. Mine, shaft caved, working on surface.

The shaft of the Falcon J. Mine caved in, the owner Mr. Julius J. Kowalewski has not announced his future plans. The shaft was down about 125 feet, and rain water was going down the shaft, ^{and} rotted the timbers.
