Brushing lines in a grid pattern and brushing of existing
roads, using chainsaws, axes, and machetes. This grid will
consist of a baseline and cross-lines, usually at 400' intervals.
These lines will be 3' to 4' wide to permit access through
brush. All trees will be left alone. This work will be done
intermittently during the period November 1, 1979 through
January 31, 1980. A supplemental plan of operation will be
submitted, should additional future work be contemplated that
might involve surface disturbance.
