MG WR 7/8/83: A watchman lives at the Grubstake Mine, Santa Cruz County. There are many different pieces of equipment on the property. During the early part of this year, John Frye mined some fresh rock from the Grubstake. It appears that he was crushing and grinding this material to about 1/4 inch and cyaniding it in a large truck-mounted cement mixer. The watchman said there has been no mining since April.

MG WR 7/8/83: Mr. Duane Arnold, ex-mine engineer at the Brick mine, was hired by Mr. Floyd Durkee of Oklahoma, to sample the Grubstake Mine, Santa Cruz County, prepare mine maps, and write a report on the mine's potential. Mr. Arnold defined a small tonnage of gold ore and recommended the mine for further exploration and development. Mr. Durkee, the potential buyer of the property, has had the area flown for infrared aerial photographs; according to Arnold, these photographs define several major vein structures. Although Mr. Frye is negotiating the sale of the property, the Whittinghills of Arivaca are still part owners.

MG WR 7/13/84: Mr. Floyd Durkee (c) reports he is in the process of buying the Grubstake mine in Santa Cruz Co.

RRB WR 2/27/81: George Lottridge of J.T. Enterprises, Vancouver, Washington, called to inquire about the availability of custom mills in Arivaca area. Mike Greeley supplied the names of Mr. Becker, Cactus Bowl Lanes, Tucson, who has a mill near Twin Buttes, and John Frye, Grubstake Mining Development, P.O. Box 115, Sonoita 85637, mobile unit 624-6646 E0436, who has a mill near Ruby.

MG WR 4/24/81: John W. Frye, President of Grubstake Mining Development Co. in Santa Cruz County called to say he has shut down operations and wants to sell. I understand, from another source, that he is asking \$400,000. I provided information on the operation to a consulting engineer calling from Denver.

MG WR 9/24/82: U.S. Bureau of Mines Reported production from Oro Blanco Mining District, Santa Cruz County. Grubstake Mine produced 195 tons in 1935 and 1937-1940. Produced: 400 pounds of copper, 1,405 ounces of silver and 156 ounces of gold.

MG WR 2/11/83: Mr. John Frey requested assistance with his precious metal recovery system at the Grubstake Mine, Santa Cruz County. He is mining ore from the Grubstake. I put him in touch with Dave Rabb who was able to visit the property and assist him.

MG WR 5/27/83: Several sources report that the Grubstake mine of Santa Cruz County was bought recently by Mr. Floyd Durkee of Oklahoma. Apparently Mr. Durkee has also purchased the Morning Star, Oz, and Rainbow properties, Tyndall District, Santa Cruz County and the Yellow Brick Road property, Oro Blanco District, Santa Cruz County.

MG WR 5/27/83: I could find no listing of the Yellow Brick Road claim, Santa Cruz County on the BLM microfiche.

VBD WR 9/3/81: I drove to the Arizona College of Technology between Mammoth and Winkelman to drop off a box of mining periodicals which they were pleased to receive. I met Jay Flumer and Louis Reinwand. The college plans to move the old arrastra on the Grubstake Claim in the Oro Blanco District to the campus sometime next week.

VBD WR 10/31/75: The Grubstake lode mining claim has been sold to Norman J. Lunde, P.O. Box 181, Arivaca, Arizona 85601. The Grubstake claim is situated in Section 19, T23S, R11E.

VBD WR 11/4/75: Gene Bailey of Arivaca stopped at office to procure maps of the old Grubstake Mine in the Oro Blanco District. He said he and the new owner Norman J. Lunde, planned to sample dumps and make cyanidation tests. If tests are successful, they will set up a very small cyanide plant. I will provide maps from my files next week. I'm certain the Phoenix office has underground maps but no copies are in the Tucson office.

VBD WR 3/4/76: I talked to Gene Bailey and Mr. Lundy. They are moving equipment to the Grubstake mine for a small cyanide leaching operation. The mine is situated in the Oro Blanco Mining District, Santa Cruz County.

MG WR 1/23/81: Talked to Harry J. Whittinghill, P.O. Box 91, Arivaca, Arizona 85601, phone 398-2390. He owns the Grubstake Mine in the Oro Blanco District of Santa Cruz County. He is leasing the mine to J.W. Fry, mobile phone 1-624-6646, unit 0436. Mr. Fry is trying to establish a gold operation; his mill is on the Grubstake and the mine is on the Sorrel Top.

Dear Mike:

The letter to Floyd Durkee states exactly my approach to looking for investors. The procedures follow the suggestions made by you, Dr. Peirce, Dave Rabb and Stanton Keith. I may be clear out in the North Forty but if I was approached to invest in these deals, I wouldn't ask for - but - would demand such required information as is outlined in the procedure as suggested. I was personally acquainted with the "bath" my Father took in the Kirkland, Skull Valley, Humboldt areas in 1925.

The proposals to invest \$850,000.00 (\$500,000.00 Frye & \$350,000.00 Durkee) could possibly be a good deal but I am going to have to see more than has been offered to date.

Floyd Durkee paid \$57,000.00 to West Twohey and Debbie Baker (the widow of Jim Twohey who committed suicide. Jim was West Twohey's brother, and owned the original claims) for 81.25% of the listed claims and W.Twohey & D. Baker retained 18.75%. My question from the outset has been- What did Durkee get for his money?

Durkee is far afield from his normal business which is oil. Floyd has been very successful, is square as a die and I hope this new venture will work out.

If you have an opportunity I would appreciate hearing from both you and Dr. Peirce as to whether I am overly cautious or just plain nuts.

RE: Prospective investment in your claims in Santa Cruz and Pima Counties, Arizona, and the operating mines and claims for sale by John W. Frye in the Oro Blanco and Arivaca Districts of Pima and Santa Cruz Counties, Arizona.

Dear Floyd:

Pursuant to the above captioned reference, I suggest that we hold these matters in abeyance until we have a meeting, establish the required factual information and formulate a plan for prospective investors based on more sound investment information. Any action taken by the interested parties must be such that would withstand the scrutiny of all State and Federal agencies, particularly the securities divisions of the States of Oklahoma and Arizona.

Floyd, I have spent a considerable amount of time and money in long distance calls to knowledgeable persons to obtain maps, plats and sources of information so that any presentation made to a prospective investor would stand up in a legal action, if it should become necessary.

The following is not an attempt to dash cold water on any enthusiasm on the part of any of us. However, certain factors must be reckoned with to protect your investment made to date and the proposed plan of development. Take time, Floyd, to analyze and evaluate everything that has transpired to date. What would your reaction be if you were approached today to invest in the Twohey claims? After you analyze the following suggestions made by persons who have spent a lifetime in "Hard Rock" mining and geology, I want to know your reaction and whether you agree that we should follow their advise:

- 1 - West Twohey has presented little more than pure speculation in his "Arivaca Explorations Report" that you gave to me. This report contains too many suppositions that can't be verified and no claim recording information nor the actual location by Section, Township & Range. The economics as presented are theory and, to my knowledge, NO ASSAYS HAVE BEEN PRESENTED THAT WOULD SUBSTANTIATE THE ACTUAL MINERAL CONTENT OF ANY OF THE CLAIMS, NOR A FEASIBLE METHOD OF EXTRACTION, AND EXPECTED RECOVERY OF MINERAL CONTENT PER TON AS WOULD BE OUTLINED BY A

REGISTERED GEOLOGICAL ENGINEER. The costs involved are an overriding factor and are of vast import not only to an investor, but to you as an owner of the majority interests.

- 2 - The John W. Frye properties fall in exactly the same category as outlined hereinabove. The burden of PROOF falls on the Seller, whether it be for investment purposes or for transfer of assets in claims, mines or machinery. A suggested procedure has been offered and, in my opinion, we should follow it.

PROCEDURE

JOHN W. FRYE PROPERTIES

1. Frye should provide a current Fair Market Value or Salvage Value appraisal of all equipment offered for sale. This appraisal must be made by a knowledgeable and currently operating company that will certify loan value. Relative to that value, age and remaining depreciation are factors and any monies paid over and above the FMV or SV of the equipment should be given serious consideration. No lending institution would approve any loan over and above the equipment FMV or SV, so why would an investor? Since selling "good will" is not an issue, the only things of actual value are the extraction and other equipment. Any other values, regardless of the seller's claims of anticipated future mineral recovery, are pure theory UNTIL a Registered Metallurgist in the State of Arizona, working independently, takes samplings from the operating mines and the remaining nine claims and identified them and submits them to an established assay office. After the Metallurgist has completed his work, a State of Arizona Registered Geological Engineer should be employed to work out all of the economics that pertain to extraction, type of equipment to be used, provide a cost analysis for the maximum results that can be expected. The Metallurgist and Geological Engineer will provide the Seller, Buyer and/or Investors the costs of mining the ore, extracting the mineral content and the minimum and maximum recovery per ton of ore mined. Any other procedure than this would be totally unacceptable to any investor since this is based on both common sense and good business acumen. It stands to reason that a Seller is not going to downplay an offering. Therefore,

reliability and the actual facts present must be the work of independent persons with established expertise.

2. It is vital that the "independent" status of both the Metallurgist and the Geological Engineer be adhered to. Their combined findings will reflect what can reasonably be expected in return on investment and over what period of time. A Seller is going to show only the best side of his wares. In this case, that is not acceptable. Only after the above procedure has been followed can differences be worked out if the Seller disagrees with the findings.

DURKEE, BAKER- TWOHEY INTERESTS

1. The above procedure should be followed on the claims now owned and/or any other claims purchased, if these interests are to be offered to investors.

I am advised that Frye has employed D.D. Rabb to evaluate both the Grubstake and Sorrell Too mines. The extent of his work is not known to me, nor whether he will evaluate the remaining nine claims included in Frye's offer for sale for \$1.5 million. Whatever the case may be, it is my opinion that Frye should provide a copy of Rabb's report to you before going any further with this.

West center end monument, or stake, and Six Hundred (600) feet in

making the claim in the form of a parallelogram.

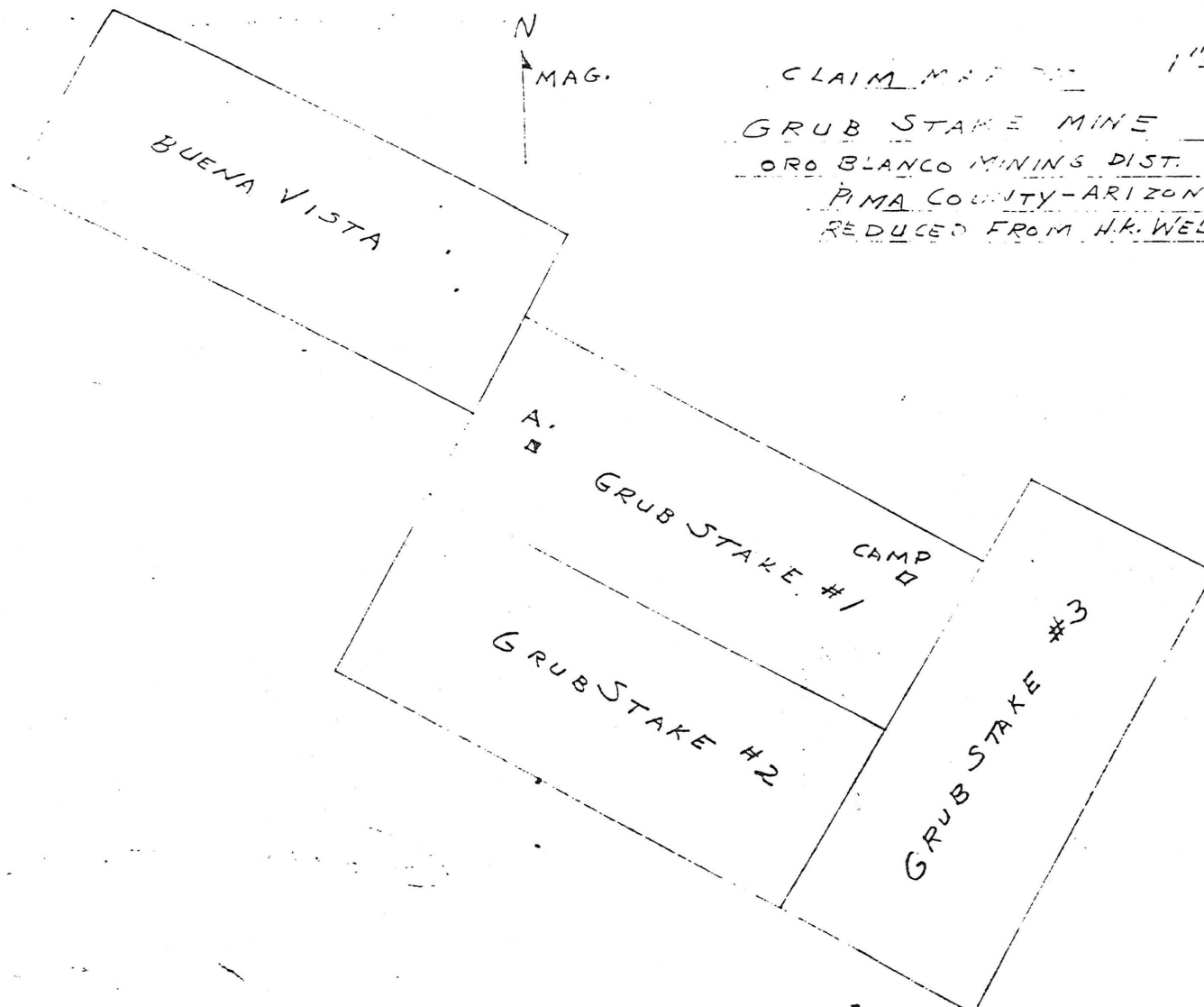
