Review of Recent Operations:   One drill hole has been completed by Metler Bros. Drilling Co. and the second drill hole is now being drilled. The drilling will take care of the annual assessment work, as well as providing geological information. Donald T. McMillan was appointed to take care of the engineering supervision last June, replacing Thomas W. Mitcham who was previously the engineering consultant for the company.

Heinrichs Geoexploration Co. is reported to have done some geophysical work on the property about 2 years ago.
