

#### MARICOPA COUNTY

KAP WR 5/15/87: Phil Chubb, a geologist working for Superburn Systems, Vancouver BC reported he is investigating a green stone property in the eastern end of the Harquahala Mountains that had been submitted to them by Floyd Bleak (card) as a landscape rock deposit. The only claims in the area belonging to Mr. Bleak are the Horn Claims in Sec 26, T5N R9W. He was interested in any geologic mapping of the area as well as any other information. Suggested he talk with the BLM regarding a plan of operations for a decorative stone property so as to make sure there would not be any "common variety" type of problems. He felt the deposit was likely chloritically altered zone. The surface explosure is about 100 feet wide and can be traced fro 750 feet on the surface. He came in later in the week to review mine files in the area.
