Crushing and Screening Equipment: The following crushing and screening equipment was found on the property:

- (1) Eagle Jaw Crusher ----8" x 16"
- (2) Shafer Rolls ---- 16" x 16"
- (3) Overstrom Screens ---- 2' x 4'
- (4) Fine ore bin ---- 8' x 10' x 2' steel
- (5) 1 belt conveyor in poor shape.

Only the jaw crusher and rolls and the belt conveyor between them was mounted in place.

Indications show a limited amount of marble had been crushed and screened, but this was not a recent operation.

Mine Workings: 1 small open cut just above the location of the crushing and screening equipment. This was shallow and not very extensive.

1 small open cut on top of the hill.

cut seems to have the best color.

1 small open cut on a hill to the right of the crusher and about 300 ft. away. The material seems to be of fair quality, about the same as that found at the Marble Top Quarry, which is about 2 miles east of the Jay Jay Claims. The last mentioned open

More exploration is required to determine the amount and grade of marble.
