




SUMMARY

John Tames, 5470 N. Cumberland Drive, Tucson, Arizona, phone 887-5650 requested information on the Justice patented claim in Santa Cruz County. We did not have any.

The location is shown by an adit symbol on the Duquesne 7.5' quadrangle, but not the same named 15' quadrangle used to establish the original AzMILS locations. Mr. Tames' son-in-law, Carl T. Sandberg, Jr., 5265 W. Sunset Road, Tucson, Arizona, phone 743-3216 owns the property which consists of a single 20 acre claim. They report the property contains a number of shallow shafts and short adits.

I suggested they request a copy of the mineral survey MS 3813 and the surveyor's notes from the BLM. It may be the only public data on the claim.
