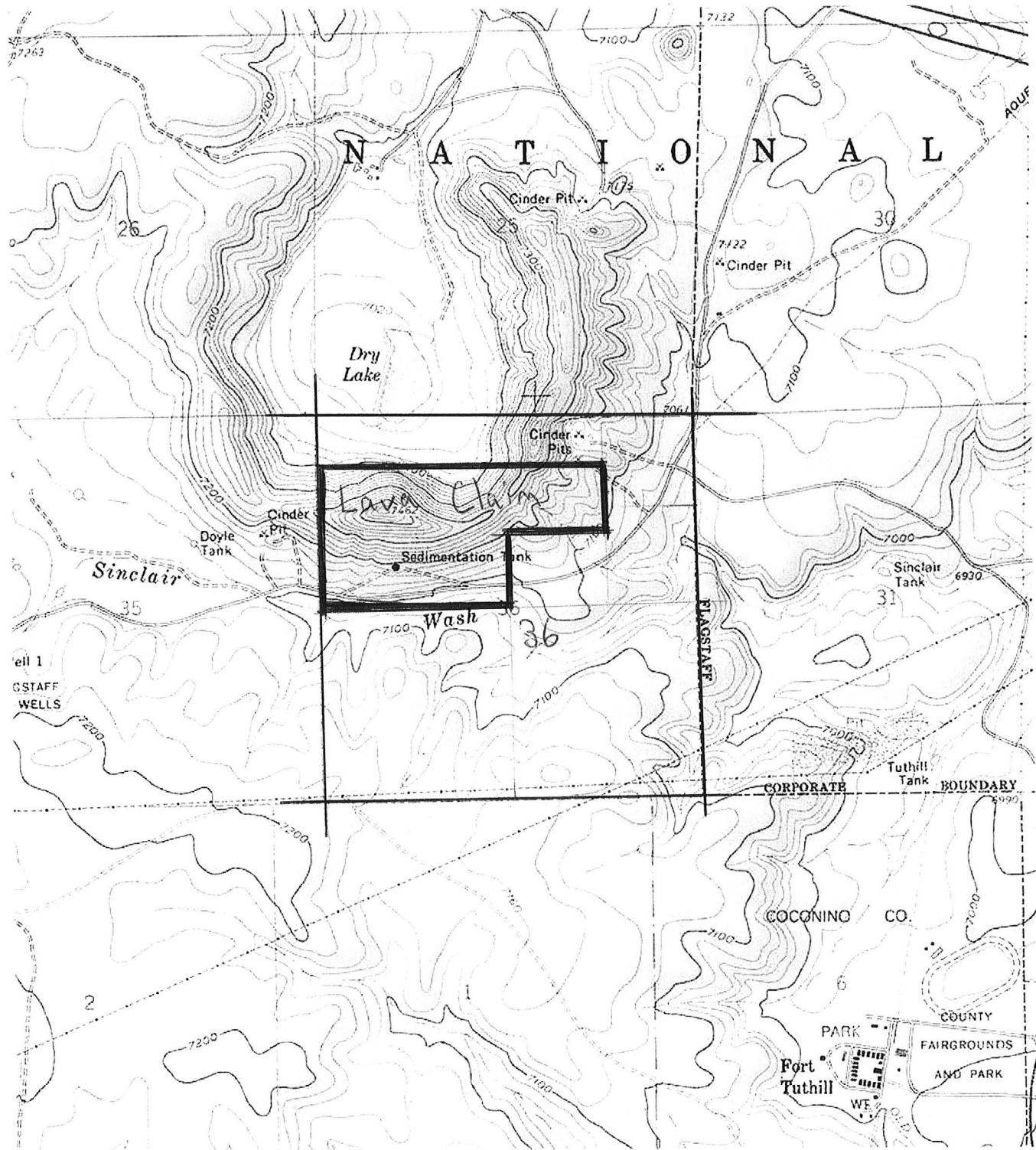

NOTICE OF MINING LOCATION

PLACER CLAIM

TO ALL WHOM IT MAY CONCERN:

This Placer Mining Claim, the name of which is the LAVA CLAIM, situate on lands belonging to the United States of America, and being a form of valuable mineral deposit other than in veins or ledges of quartz or other rock in place, was entered upon and located for the purpose of exploration and purchase by PATRICK HARGROVE, MARTIN JENSEN, SYLVAN HARENBERG, URBAN HARENBERG, LAVAUN HARENBERG, FRANCES R. HARGROVE, BETH HARENBERG, AND PEARL A. JENSEN, citizens of the United States, the undersigned, on 29th day of November, 1952, claiming one hundred sixty (160) acres thereof, more or less, and have marked the same on the ground as follows:

BEGINNING at the West Quarter corner of Section 36, T. 21 N., R. 6 E., G&SR&M, Coconino County, Arizona, at a wooden post where this notice is posted;

THENCE North along the West line of said Section 36, 1980 feet, more or less, to the Northwest corner of the ~~SW1/4~~ of said Section 36, marked by a wooden post;

THENCE East along the North line of the ~~SW1/4~~ and ~~SW1/4~~ of said Section 36, 3960 feet, more or less, to the Northeast corner of the ~~SW1/4~~ of said section 36, marked by a wooden post;

THENCE South along the East line of the ~~SW1/4~~ and the ~~NE1/4~~ of said Section 36, 1320 feet, more or less, to the Southeast corner of said ~~NE1/4~~, marked by a wooden post;

THENCE West along the South line of the ~~NE1/4~~ of said Section 36, 1320 feet, more or less, to the Southwest corner of said ~~NE1/4~~, marked by a wooden post;

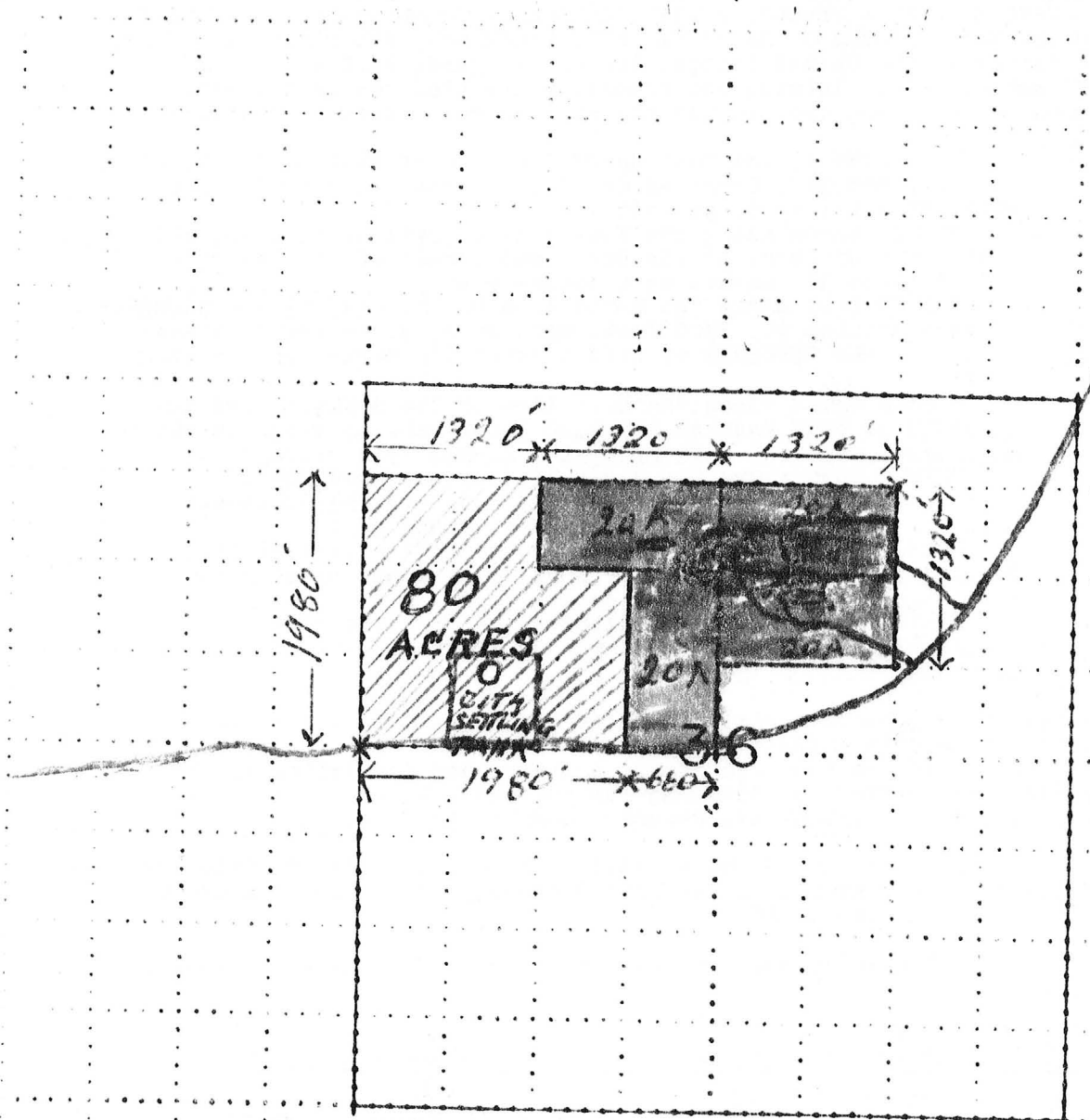
