Trip to Leadview property with Mr. Munez, Mr. Barrios & Russ Williams.

Located approximately $1\frac{1}{2}$ miles in a Southerly direction from the Goswick ranch on left fork of Big Bug Creek.

Russ Williams & myself met Munez and Barrios at Poland Junction at 9:00 A.M. We all rode in pickup to Leadview mining property arriving about 9:20 A.M.

The first shaft we saw was reported to be about 45 feet in depth. This was a one compartment shaft about 5'x5', the timber still intact with ladderway. Didn't have rope so did not enter. According to Mr. Munez the veix at the bottom was $l^{\frac{1}{2}}$ ft. to 2 ft. wide, lead, silver & gold ore. (Earlier samples taken by Munez and Barrios from specimens from dump assayed 56: Pb, .01% Zn, 12.8 Ag, .03 Au. with 33.6% of the lead non-sulfide.)

Located about sixty feet in a North Westerly direction from the first shaft mentioned, another shaft said to be about two hundred feet in depth. This shaft about a 6'x8'. Timber has rotted out and vein can be viewed on both sides from the collar, down to a distance of about 20 or 30 feet. Average width of vein about 20 inches of what can be seen.

Mr. Munez thinks the vein to be about 3 ft. wide at the 200 level as told to him from some other source.

Vein between two shafts running North 40° East. 83° dipping to West.

Then proceded on foot from these two shafts in a south-westerly direction to the divide between Big Bug & Grapevine Creek. Were shown two quartz blowouts on this ridge.

Then topped over ridge about two hundred feet on Grapevine side, Monument located here and more quartz float, no vein found as yet.

Took sample of footwall, hanging wall, waste specimens from dump, ore specimens from dump & of quartz from Grapevine Creek. Sample of quarts being assayed for Gold & Silver.

Seven claims staked on the Leadview. Three claims on the Crystal Copper, these are ajoining the Leadview claims.
