The claims are named the Lilly Mining Company Numbers 1 - 10, Sunflower dist., Maricopa County. He has been prospecting and sampling the deposit for a number of years. He reported gold values up to 2 tr. oz/gon. He said that according to George Aboud the ore would be difficult to process because of the mercury content.
