Subject: Interview with John Machulies, 920 W. Indian School Rd., Phoenix

Location: South of Champie Ranch and N of Castle Hot Springs in very rough country (no road to property).

Material: Tuff

Property: No claim. Machulies was undecided as to whether he wished to locate it, but plans to study the accessibility of the locality to see if a reasonable cheap access road could be put into the deposit.

Geology: A bed of white tuff, 20 feet thick, and of considerable lateral extent.

Mr. Arthur Flagg, according to Machulies, pronounced it as very good tuff, but its location and the market conditions at that time, did not warrant trying to open it up further, so that it has not been claimed.
