

	It seems he spent considerable money (over \$100,000) on a partnership with some
	friends to develop the placer deposit. He further paid off their delinquent
	lease on the property from Les Bender and purchased the claims outright. Appar-
	ently, in the meantime his partners assigned the claims to Del Oro Placers.
	Del Oro Placers eventually sued in the State Court of Appeals awarded the claims
	to them and therefore, he no longer owns any interest in the claims.
