

DRILLED HIS LAST ROUND

Miners, prospectors, students of nature and lovers of the great outdoors lost a friend and fellow when Harvey, Riggs; 78, died at his Arivaca, Ariz.


Riggs, a gambasino of the old order, was involved with mines and mining much of his life. He at one time operated the old Union Mine on the Arizona-Sonora border west of Smuggler's Gulch in Santa Cruz County. He held a number of claims in and about the Arivaca District at the time of his death, many of which are currently under lease-purchase options.

home Oct. 7 following a heart attack.

Born in Chelsea, Cherokee Indian Territory (Oklahoma) in 1898, he moved with his parents at a tender age to a ranch in the Sacramento Mountains of New Mexico in the Alamagordo area. Riggs' father thought his son should have a military career and enrolled him in the New Mexico Military Institute but the lad wanted none of the spit-and-polish discipline and stowed away in a load of hay being freighted southward toward the border. Discovered, he was returned home.

Typical of Riggs were his observations about an 18-month bout at studying law under a Texas judge. He explained his decision to give up that endeavor with, "I could never defend a man I knew to be guilty, and besides, I had no desire to be involved in legalized theft nor to obtain a license to steal."

World War I saw the young man patrolling the border out of El Paso, Texas with the Army Air Corps in aircraft. Later he was employed in Arizona and New Mexico by the Forest Service. A one-time justice of the peace at Patagonia, Ariz., Riggs resigned that post to enter civil service. He spent 18 years as a general contractor with headquarters in Nogales, contracting jobs for Santa Cruz, Cochise and Pima counties. Riggs also built fences, roads

and phone lines in Arizona and New Mexico for the Forest Service.

Ill health brought semi-retirement in 1947 and he settled in Arivaca where he became interested in the history of northern Sonora and southern Arizona, devoting considerable' effort to research of the Arivaca area. Riggs established the Arivaca Briefs in 1948 and published it for 26 years until ill health forced its suspension. The Briefs was distinguished as that community's only newspaper, and was a "unique sheet," reflecting much of the editor's personality.

A life member of the Arrivaca Council, Arizona Small Mine Operators Association. Riggs headed that council

several times. He was also a charter member of the Gringo Wetbacks, a long-time Mason, a member of Pimeria. Alta Historical Society, president of Ali Bac Historical Association and a member of the Tucson Press Club.

Surviving are his wife, Mary, of Arivaca; sons Harley of Ore City, Texas and Guy of Poughkeepsie, N.Y.; a brother Arthur Riggs of Tucson and a sister, Nada Banta, of Patagonia, Ariz.

Harvey Dewitt Riggs, long-time small mine operator, died October 7th at his home in Arivaca at the age of 78.

Memorial services were held the following day in the Carroon Mortuary Chapel in Nogales, with the Rev. John Arnold of Tucson officiating. Interment was in the Patagonia City Cemetery with Masonic graveside rites conducted by Nogales Lodge No. 11, F&AM.

Location Seds. 29 and 30 -- T 20 S -- R 10 E. About 2 miles east of Las Guijas.

Number of claims 60 unpatented claims on Federal land. Some of these claims were located by Chas. Mareydt and Harvey Riggs in Oct. and Nov. 1960. The remainder were located by Mr. Mareydt, Harvey Riggs and W. D. Roper in July 1961.

Principal Minerals Copper, with some molybdenum

Present Mining Activity Diamond drilling on contract by Metler Bros Drilling Co., Tucson Drilling is done with one diamond drill, working one shift. Drilling is reported to have started on Sept. 2.

Ore Values Mr. Mareydt reported that he took about 30 samples of the ore last fall and this spring, and that 40 additional samples were taken in July, 1961 by himself and Mr. Roper. He stated that these samples ran from 1.78 % in to 6.00 % in copper, with about fixed 0.04 % molybdenum. He stated that the copper was all oxidized, but expected to find sulphides in depth.
