SUBJECT: Noscut Mine

Consists of 10 patented claims in the Helvetia Mining District 7 miles S. W. Mountain View by good road. Owned by Noscut Mining Company, Dr. Toole, Bisbee Agent, and leased by C. J. Hall, 811 E. Drochman Street, Tucson, Arizona.

This is located in the northern foothills of the Santa Cruz Mountains and is the extremelnorthern end of a series of limestone beds dipping about 40° S. E. Replacement of lime by galena and sphalerite carrying 4-5 ozs. silver.

Opened by a tunnel about 150 feet with some stoping from which ore was sorted and shipped about the time of World War I. There are several cross fissures also containing values and a winze about 100 feet deep was sunk on one of these junctions. Ore averages \$22 in values. Spotty.
