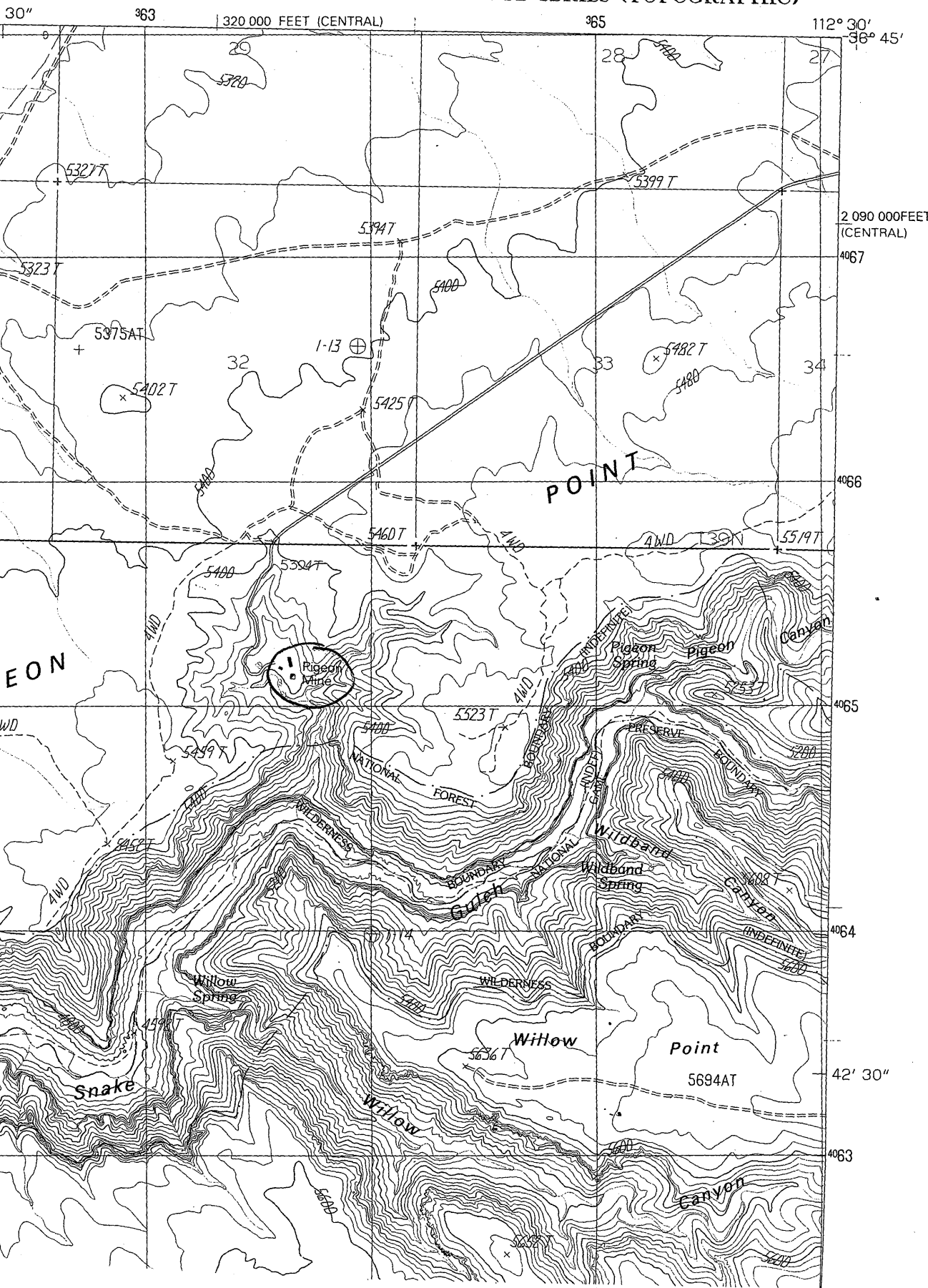

On or about March 31, 1997, all Hack Canyon, Pigeon, and Arizona 1 Mine assets of Energy Fuels Nuclear, Inc. (EFN), will be transferred to a new company named International Uranium [USA] Corporation (IUC). IUC will own and operate the Hack Canyon, Pigeon, and Arizona 1 mines pursuant to the conditions of the current APPs. Financial assurance for closure and post closure costs were approved by the Water Permits Section - Mining Unit (WPS-MU) of the Arizona Department of Environmental Quality (ADEQ) on February 19, 1997.

#### **Hack Canyon Mine**

The Hack Canyon Mine site is located approximately 30 miles southwest of the city of Fredonia in Coconino County, Arizona over groundwater of the Kanab Plateau

The Pigeon Mine site is located in the southwest ¼ and north ½ of Section 5 of Township 38 N, Range 2 W, Salt River Baseline and Meridian in Coconino County, approximately 15 miles due south of the City of Fredonia, Arizona. The facility is located over groundwaters of the Kanab Plateau groundwater basin. The facility is currently inoperative and will be permanently closed under this Aquifer Protection Permit.

The Pigeon Mine operated as an underground uranium mine. Major components of the mining process at the facility included mining and stockpiling of ore, collection and evaporation of mine water from 2 lined containment ponds, and routine operational and maintenance activities associated with an operation of this nature. No ore processing occurred at the facility. All ore produced was transported to a mill in Blanding, Utah for processing.

Site construction commenced at the facility during March 1982 with mining operations concluded in January 1990. Site reclamation was completed in March 20, 1991. The mine produced approximately 195 tons of ore daily. Total ore recovered during operation was 439,000 tons.

A Notice of Disposal was filed with the Arizona Department of Environmental Quality on December 26, 1984. The facility obtained a NPDES Permit to provide for anticipated mine water discharge. Mining operation encountered limited connate water and this was collected and evaporated from a lined containment pond. No water was discharged under the NPDES permit.

The permit and related materials are available for public review Monday through Friday 8:00 a.m. to 5:00 p.m. at the Arizona Department of Environmental Quality, Aquifer Protection Program Section, 3033 N. Central Avenue, 4th Floor, Phoenix, AZ 85012, and at the Fredonia, Arizona, Public Library.

Persons may submit comments or request a public hearing on the proposed action, in writing, to Michael Wood, ADEQ, at 3033 N. Central Avenue, Phoenix, AZ 85012 within thirty (30) days from the date of this notice. Public hearing requests must include the reason for such request.

It is apparent from the above table, that within the last 7 years, exploration activities has resulted in approximately 648.6 acres of disturbance. However of this disturbance, approximately 533.5 acres have been reclaimed.

Even if reclamation were not a requirement, the total percent of surface disturbances compared to that in the resource area or the area of high mineral activities would be very small, generally far less than one tenth of a percent.

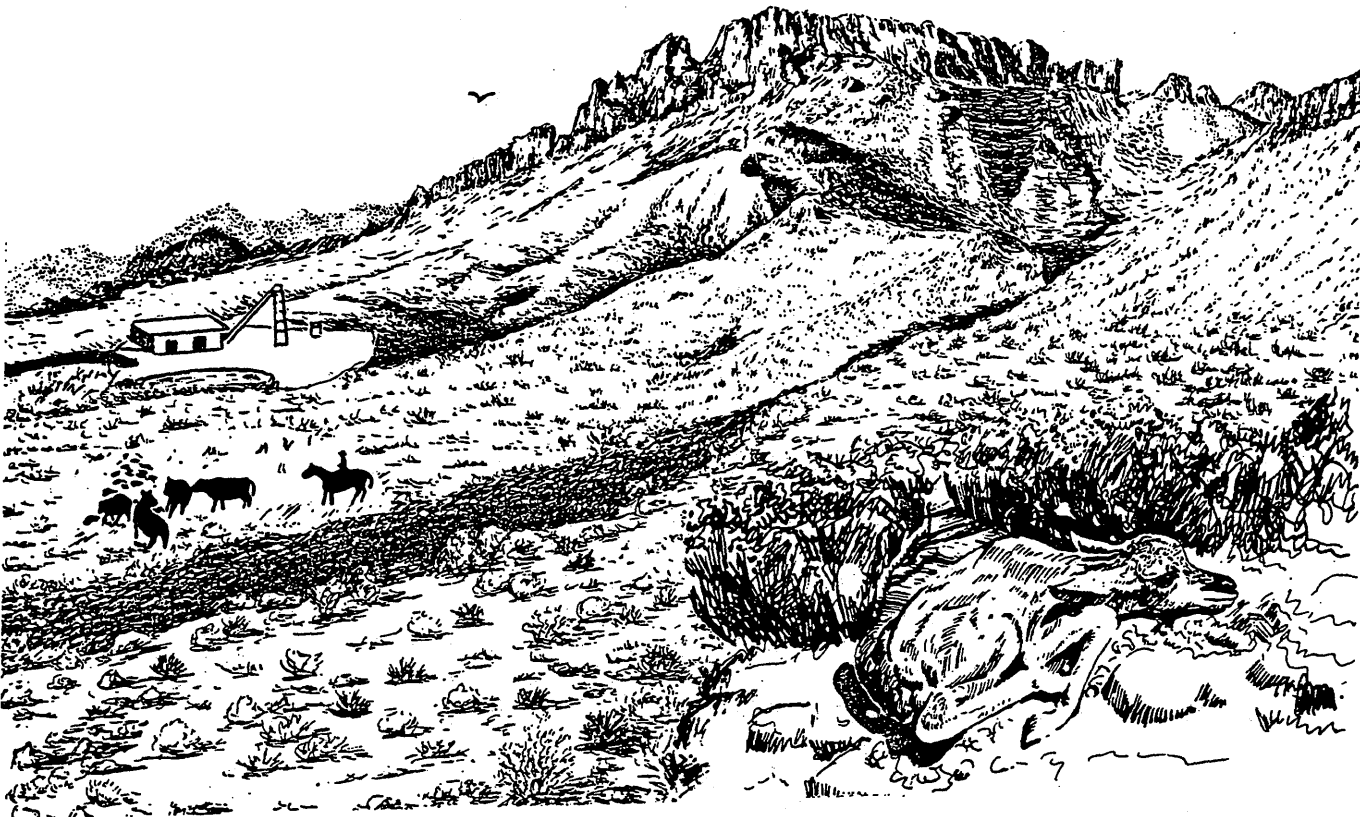

The applicant proposes to operate the Pigeon Mine located south of Fredonia in Coconino County, State of Arizona. The proposed discharge will consist of mine drainage water. The discharge at latitude 36°43'30"N, longitude 112°31'40"W will be to Snake Gulch, tributary to Kanab Creek. The protected uses of Kanab Creek are Aquatic Life and Wildlife, Partial Body Contact and Agriculture Livestock Watering. The United States Environmental Protection Agency has established effluent limitations for this industry. This permit, as proposed, will expire May 31, 1987.

A public notice for this proposal to issue a permit was originally issued on April 5, 1982. A public hearing was held in Fredonia on July 14, 1982. The purpose of this notice is to reopen the comment period for 30 days from the date of this notice. The EPA is particularly interested in comments, data or information pertaining to the following issues as they apply to this proposal to issue a permit:

1. How the permit can ensure compliance with Arizona Water Quality standards in the receiving stream.
2. The feasibility of total containment of mine drainage water.
3. The feasibility of restricting wastewater discharges to periods when there is flow in the receiving stream; the minimum receiving stream flow rate which should be required for discharges to be permitted.

The State is considering a request to certify the discharges described above, pursuant to Section 401 of the Act. The certification will set forth any limitations and monitoring requirements necessary to assure compliance with any applicable effluent limitations and other limitations, under Sections 301 and 302 of the Act; standard of performance under Section 306 of the Act; or prohibition, effluent standard, or pretreatment standard under Section 307 of the Act; and any other appropriate requirement of State law. No permit will be granted if certification is denied by the State.

The Administrative Record, which includes the application, draft permit conditions and other relevant documents, is available for public review Monday through Friday from 9:00 a.m. to 4:00 p.m. at the EPA address shown above.

A copy of the draft permit, and other pertinent documents, may be obtained by calling or writing to the NPDES Records Clerk at the Regional Office of EPA at the above address.

Persons wishing to comment upon or object to the proposed determinations or request a public hearing pursuant to 40 CFR 124.12 should submit their comments or request in writing within 30 days from the date of this notice, either in person or by mail to:

All comments or objections received within 30 days from the date of this notice will be considered in the formulation of the final determinations regarding the applications. If the response to this notice indicates a significant degree of public desire for a public hearing, the Regional Administrator shall hold one in accordance with 40 CFR 124.12.

If no public hearing is held, final determinations will be made shortly after the close of the comment period. The permit will become effective 30 days following the date when final determinations are signed.

A request for an evidentiary hearing may be submitted to the Regional Hearing Clerk within 30 days following the final determinations, in accordance with 40 CFR 124.74. If granted, applicable provisions of the permit will be stayed pending the results of the hearing.

The certification will set forth any limitations and monitoring requirements necessary to assure compliance with any applicable effluent limitations and other limitations, under Sections 301 and 302 of the Act; standard of performance under Section 306 of the Act; or prohibition, effluent standard, or pretreatment standard under Section 307 of the Act; and any other appropriate requirement of State law. No permit will be granted if certification is denied by the State.

The Administrative Record, which includes the application, draft permit conditions and other relevant documents, is available for public review Monday through Friday from 9:00 a.m. to 4:00 p.m. at the EPA address shown above.

A copy of the draft permit, and other pertinent documents, may be obtained by calling or writing to the NPDES Records Clerk at the Regional Office of EPA at the above address.

Persons wishing to comment upon or object to the proposed determinations or request a public hearing pursuant to 40 CFR 124.12 should submit their comments or request in writing, within 30 days from the date of this notice, either in person or by mail, to:

All comments or objections received within 30 days from the date of this notice will be considered in the formulation of the final determinations regarding the applications. If the response to this notice indicates a significant degree of public desire for a public hearing, the Regional Administrator shall hold one in accordance with 40 CFR 124.12.

If no public hearing is held, final determinations will be made shortly after the close of the comment period. The permit will become effective 30 days following the date when final determinations are signed.

A request for an evidentiary hearing may be submitted to the Regional Hearing Clerk within 30 days following the final determinations, in accordance with 40 CFR 124.74. If granted, applicable provisions of the permit will be stayed pending the results of the hearing.

Persons wishing to comment upon or object to certification by the State should submit their comments in writing within 30 days from the date of this notice, either in person or by mail to the State at the address given above.
