

Subject: Progress report on "C" loan.

Briefly reviewing the original situation in this case:

A tunnel had been driven into the mountain through quartz monzonite in a northeasterly direction for about 150 feet, thence due north for 122 feet at which point it cut at right angles a strong copper vein dipping about 65° south. Aside from other workings, drifting was continued to the east on this vein. At a distance of about 75 feet from junction, vein widened out to full width of drift, about 5 feet, carrying commercial values in oxidized copper ores together with some chalcocite. This ore shoot continued for 80 feet before pinching down to a foot or so. At the point where the change of direction occurred in the tunnel a winze had been sunk about 100 feet. This was later opened to the surface, about 60 feet. Winze was full of water, but it was reported that a crosscut had been started to the ore shoot and about 40 feet of work yet remained to be done to cut this ore.

The winze has since been unwatered to 90 foot level, and put in shape for hoisting. The lower crosscut was continued about 20 feet farther at which point the vein was cut to about 8 feet but not to footwall. However, instead of this crosscut being made in direction of ore shoot, it was found on unwatering that it extended about 65 feet almost paralleling the upper x-cut, or N,12 E. Hence, it will be necessary to drift nearly 50 feet east on the vein to the ore shoot, even though the latter has no rake to the east as suspected. Some 15 feet of drifting has been completed at present, at least 35 feet remaining with a possible allowance for rake of shoot.

The vein matter is heavy iron sulfide with occasional small masses of glance. It is making considerable water on the footwall side, hence the vein was not crosscut to the wall. In fact, water has been troublesome, and was the reason why the preliminary work was not completed within the limits of the loan. Following unwatering, the pump broke down, before a hoist had been set, and before arrangements had been made to bail, water was well up in the winze again. A pump jack has since been purchased and will be installed shortly. Meanwhile the water is being kept down by bailing and is making less as drainage is effected, about 3000 per day at present.

The loan, \$5000 has been expended economically and work done efficiently. No previous information was obtainable on the direction of the crosscut below, it being assumed that items or reported, that it extended 80 odd feet in the direction of the ore shoot. Furthermore, the water situation was unavoidable, and handled as well as possible. These circumstances have militated to prevent completion of the preliminary work as anticipated and outlined. It is believed that from \$2000 to \$2500 additional will be required to put the operator on commercial ore, construct ore bin, lay track, procure car and additional operating equipment, and meet payroll for six weeks until returns from shipments are available.

In view of the loss sustained, over \$1000 on account of water, and \$500 due to non-existence of data on extent of workings from the bottom of the winze, it is recommended that additional money be made available to put this operation on a producing basis. The formation on the lower level is identical with that

in the tunnel level. The vein is at least 8 feet wide, and there is no reason whatever to expect that the ore shoot will not be entered with the additional development outlined. However, due to the water encountered, it will be necessary to expedite assistance to avoid repetition of a great deal of work.

Patagonia Subject: Progress report.

I visited this mine at the request of the owners. Carico has the water out of the shaft and the crosscut on the 90ft. level. The shaft is in good shape although not true - twisted and will require considerable squaring up. However, for the present, Carico is using a bucket and will not spend any money on the shaft until he has enough ore to warrant it.

He was back in the cross cut. There is one caved area but he was able to get through. It measures 82 ft. so the original estimate of about 40 ft. to ore is approximately correct. Shaft was 90 ft. rather than 110. but there is a sump, full of muck, which he has not cleaned out yet. It is not making much water, apparently. There is a cross fracture in the tunnel about 15" of pretty good ore which was not previously reported. It seems to be making from the main vein, and if the latter is of the same grade, he believes it will be better than expected.

He has a hoist and was getting it up on the hill above the winze, there is an opening to the surface from the tunnel level, about 60 ft. Some timbering will be required but not much.

The county blade has been over the road, about one mile from the Flux Canvon road to the portal. Road is now in good shape. There are five men working. They expect to start work on the crosscut in a few days, and hope to be on the ore in three weeks, at most. All live in Patagonia, about five mile trip.

The job has been done economically and expeditiously so far. Carico hopes to be able to do considerable drifting with what he has, and the raise will undoubtedly take care of itself. He bought an International one-ton job cheap, good rubber, and has access to an ore truck when it comes time to ship.

These four claims, formerly known as the Hulda, are now owned by M. Carico of Patagonia and Mrs. Henrietta Miller, 1110 St. Mary's Road, Tucson. The property is situated about 5 miles southwest of Patagonia, just off the Flux Canyon Road, in the Richeson Mining District. Access good.

There is a tunnel cutting the ore at about 200 feet, drifting carried on about six hundred feet along the vein. Stands almost vertical to about 75° in monzonite. Ore shoot five feet wide for a distance of 80' showing Cu which assayed along entire distance 5 to 5 1/2 percent. Vein continuous but smaller along drift. At about 100 ft from portal there is a winze 110 ft deep, and full of water. It has been raised to surface, about 60 ft. Water has been lowered in past for use of cattle and recently showed timber in good condition.



It is reported by/previous owner that there is a cross cut on the 100' level toward vein, 75', and about 45' still to go to ore. Work discontinued by death of owner, Ashburn of Nogales. Several hundred tons of ore highgraded from dump, only about 75 tons remaining. No ore reported shipped by owner.

The present owners wish to secure a prel. devel. loan to unwater, and complete x-cut to ore, giving additional 100' of backs.

There is no equipment on the property. Ample water available, good access and no problems apparent. Have recommended fresh sampling for 3 assays to accompany applic.

Dear Mrs. Miller:

I received the report by George Ballam dated February 11 and \*phoned Mr. Ballam at Patagonia and talked with him regarding your property. I also called on Mr. Gohring and discussed with him your situation.

There is no way to get immediate quick action on an additional loan to carry on your work. Hence, I advised George Ballam to see Carrico and have him take two good samples of the vein material which you cut from the crosscut tunnel at the bottom of the vertical winze, which I believe now is cut through to the surface, so that we may call it the vertical shaft.

There seems to me to be only two courses for you to follow: One is to stop all work and apply for an additional loan. The other would be to try and interest private capital to take over your property or have Carrico or someone else take a lease on taking ore out of the vein which is exposed on the tunnel level.

I believe it will be necessary to let the water fill up to its proper level in the shaft unless you personally can arrange to keep it unwatered.

Government funds cannot be made available to continue the work without the lengthy procedure of a new application for a loan. As the showing made on the preliminary development work did not accomplish the work expected. I believe it will be rather difficult to get the additional loan but I suggest that you carefully consider it and I would be glad to talk it over with you. I am sorry this seems to be the situation.

Dear Vic:

I have been thinking over your inquiry for a small copper property for a client in Los Angeles and before I mentioned a property to you that I knew would fill the bill I wrote the owner and asked if a deal would be considered. I had a 'phone call this morning saying, yes, they would consider a deal.

The property is the Prosperity group located about three miles out of Patagonia in an ideal section at an elevation of between four and five thousand feet. The owner of the property is Mrs. Henriette E. Miller, 428 East 8th St., Tucson, telephone 2787-M.

The property is very well located in a beautifully timbered section with an ideal camp site and sufficient water close by. There is a tunnel which exposes an ore shoot 80 feet in length running 5% or better in copper with some gold and silver. The first portion of the tunnel is a cross cut and from this tunnel a winze is down 110 feet and a cross cut from it which is within 25 feet of cutting the ore shoot now exposed in the tunnel level.

I have examined the property hastily and our field engineer, George Ballam, examined it also and it can be made a ready shipper. Application for a Preliminary Loan was made on this property and the loan has been recommended by this office. The owner, Mrs. Miller, is willing to sell and I believe it would be possible to have the loan assigned or transferred to anyone who purchased the property. Or if they so desired merely cancel the application for the loan.

It seems to me this property would be an ideal one for the party you mentioned. My suggestion as to the deal that should be made is that a three or four thousand dollar cash payment would take the property with a 10% royalty agreement without any strings whatsoever attached until a full payment of between \$7,500 or \$10,000 could be made. It might be possible for you to make much better terms with the owner, Mrs. Miller, and if your man is in Los Angeles and ready to deal I believe Mrs. Miller would come to Los Angeles to discuss terms. But it would be far better for you to come and see the property, take an option in your own name and then make whatever deal you could with your client.

If you desire further information I would suggest that you contact Mrs. Miller direct in Tucson.
