## OPERATORS AND OWNERSHIP

The Purple Pansy mine and others formerly owned by Smith and Seifert, Aguila, were recently acquired by the Ambrosia Mining Co. of Alberquerque, N. M. The operation of the properties and mill is being carried under the name of Herald Mining Corp. Box 12, Aguila. The Ambrosia Mining Co. appears to be the parent Company.

Officers of the Herald Mining Corp. are Neil Rice, Mining Engineer - Ted Biddle, Metallurgist - John Wite, Mill Supt. - John Kennedy, Auditor.

## Purple Pansy Mine

This property was opened up by Smith and Seifort several years and some ore from it was shipped to the Wenden Depot. The grade of the ore proved to be a little too low for direct shipment to the depot and some ore was sent to a custom mill at Aguila for upgrading. This did not make a satisfactory recovery so Smith and Seifort built a mill for mine at a site about 11 miles south of Aguila where water was available. After many tries and alterations in the mill, the project was given up as a failure. Production from the property to this point is reported at about 30,000 tons of ore averaging 9% manganese.

Present operators have done considerable drilling on the property since acquiring it and estimate as now developed some 900,000 tons of 8% grade.

## PRESENT MILL

The mill is on the site of the original Smith and Seifort Plant. There is coarse and secondary crushing to obtain a product through  $3/4^n$  mesh which goes to a Wemco sink-float unit which produces a satisfactory concentrate of better than 40%. The fines are separated from the sink-float tails and sent to tables for further treatment. (When the mill was visited Oct. 18, the tables were not doing a satisfactory job as they were very much over-loaded. Mr. Wite the mill supt. stated that more tables were being installed to relieve the situation). The mill capacity is 600 tons of crude ore per day. The ore is hauled from the Purple Pansy mine by truck, a distance of about 4 miles. Concentrates are hauled to Aguila for shipment.

Mr. Wite stated that during the initial months operation about 60 tons of sink-float product was produced per day, the present table concentrate is being stored for further treatment. That the indicated recovery from sink-float was 55% and with proper table operation the overall recovery would probably be around 70%. He also stated that plans are to install another sink-float unit and additional tables to increase the capacity to 1200 tons of crude ore per day.
