HM WR 4/1/88: In the company of Bill Owenby, Saunders Road, Huachuca City, Az 85616, the Ranch 1-21 lode claims in Guadalupe Canyon, Cochise County were examined and sampled. Mr. Owenby had two assays which reported .04 & .1 opt gold contained in a limestone and sandstone sequence adjacent to a rhyolitic volcanic complex. No mineralization had previously been reported from the area, but if the assays were correct, a sediment hosted gold deposit model might be applicable. A report of examination will be prepared upon receipt of analytical data.
