KAP WR 8/1/80: Don Alexander of Prescott reported he is moving to Craig, Colorado, and wants to sell his placer gold claims on Hassayampa River. His Rhino-D Claim is in Sec. 26, T12½N, R2W, Yavapai County. He has done some sample dredging on the property with fairly good success. He is asking \$5000 for the claim.

KAP WR 8/6/79: Mr. Don Alexander, 1529 Idylwild, Prescott, Arizona 86301, phone 778-4697, (work phone 445-2700 Ext 132), reported he has sold four of his Double D Claims to Bob Rose.

KAP WR 3/18/80: A field interview was held with Don Alexander, owner of Prescott Gold Prospectors, a prospector supply shop in Prescott. He reported on the high level of amature prospecting activity in the Prescott area. He also reported that he has recovered approximately 8 ounces of placer gold from his D & D Claims, Hassayampa District, Yavapai County.

KAP WR 11/21/80: A letter was received from Don Alexander, formerly of Prescott, Arizona, now of Craig, Colorado, saying he is still trying to sell his Rhino-D Placer Claims in the Hassayampa District, Yavapai County. The following is a quotation from his letter of November 10, 1980, discussing the current status of the claims:

"Would like for you to know I want to sell the Rhino-D Placer Claim of 20 acres on the Hassayampa; and, if you have some one ask you about a pretty good claim on a stream which runs year-round I'd appreciate you mentioning me to them. My annual work was done and properly recorded with County and BLM in Aug '80 so I'm good for another year. But, knowing I'll not be down there to work the claim it is best to sell it and take \$ before I have a squatter who takes the claim away from me. I'd like to get \$2000 for it if I can. Waht do you think about my price? You will recall this claim is located on the upstream side of the Double-D 1-4 Claims I sold to Gold King. I've taken about 2-1/2 ounces in about a year's time but only worked su-mer of '79 off and on for about 3 months."
