We then drove to Mr. Tapia's mining claim named San Francisco No. 1 in Section 27, T7S, R18E. A near vertical fault striking N60°W contains copper oxides and wulfenite. NJN WR 5/13/88: Dave Scott of the U S Bureau of Mines, IFOC in Denver is reviewing the Arivaipa area mineral occurrences before the BLM expands that wilderness area. He was interested in the San Francisco #1 (file) Pinal County which I discovered was mislocated in Sec 27C. The correct location is Sec 34 N2. This location is critical as the southern boundary of the land exchange for the expansion of the wilderness area includes Sec 27 but excludes Sec 34, thus leaving the property unaffected. The property is still held by Frank Tapia (card) whose new address is 1669 Circle B, Tucson, Arizona 85713.
