GWI WR 11/13/80: Ralph Griffin, owner of Sonoma Mine, called for information on shipping ore.

KAP WR 12/23/83: Ralph Griffen, Ph: 883-4799 reported he is continuing to work and live on his Sonoma patented mine. He is concerned about being able to produce marketable ores or concentrates from his complex silver=lead-zinc-copper prospect. A number of possible processing methods were discussed. However, the necessity of proving an adequate quantity of ore in the deposit was the first priority followed by determining the metallurgical mineralogy. Maps of the location of the property have been provided.

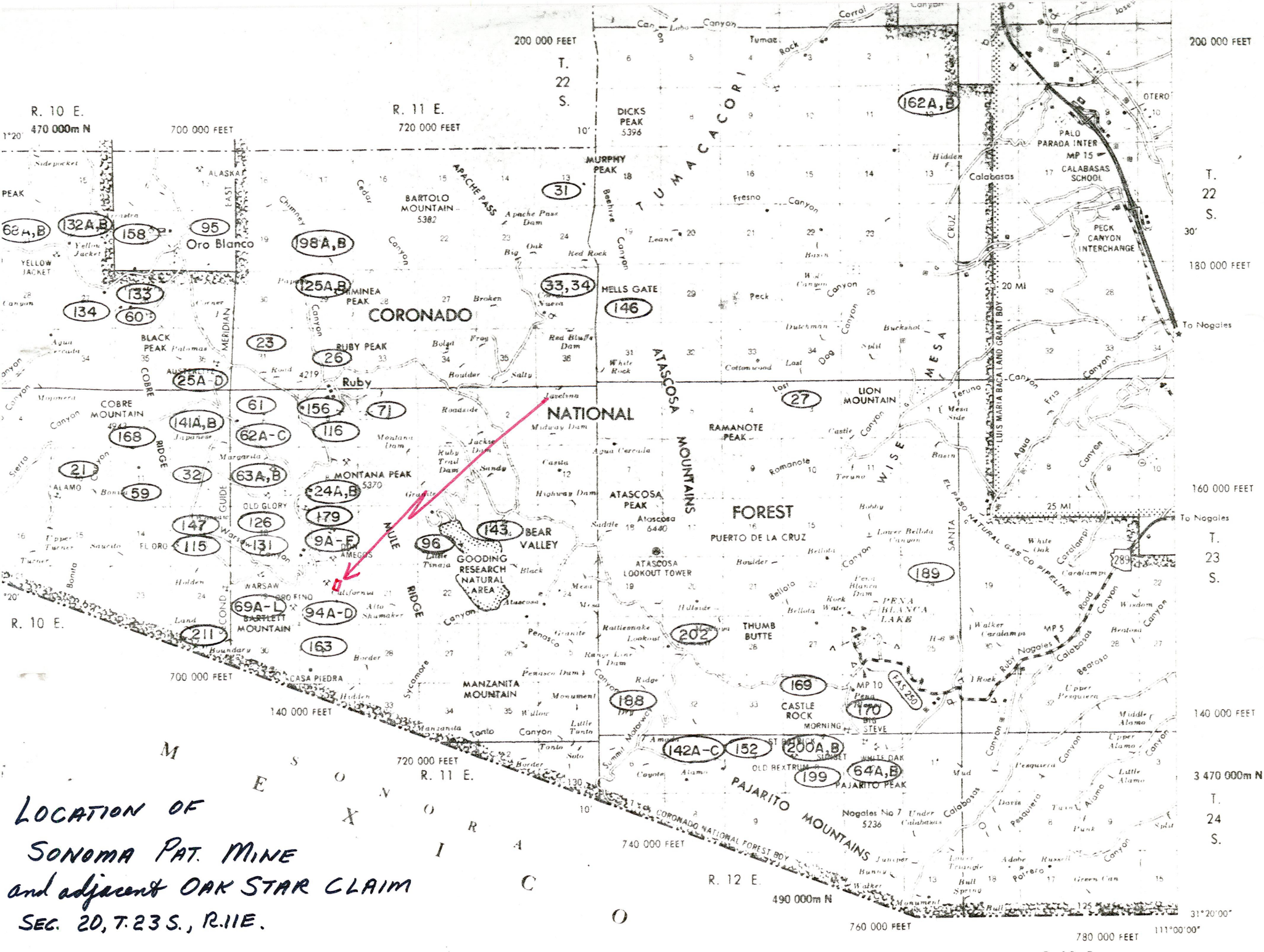

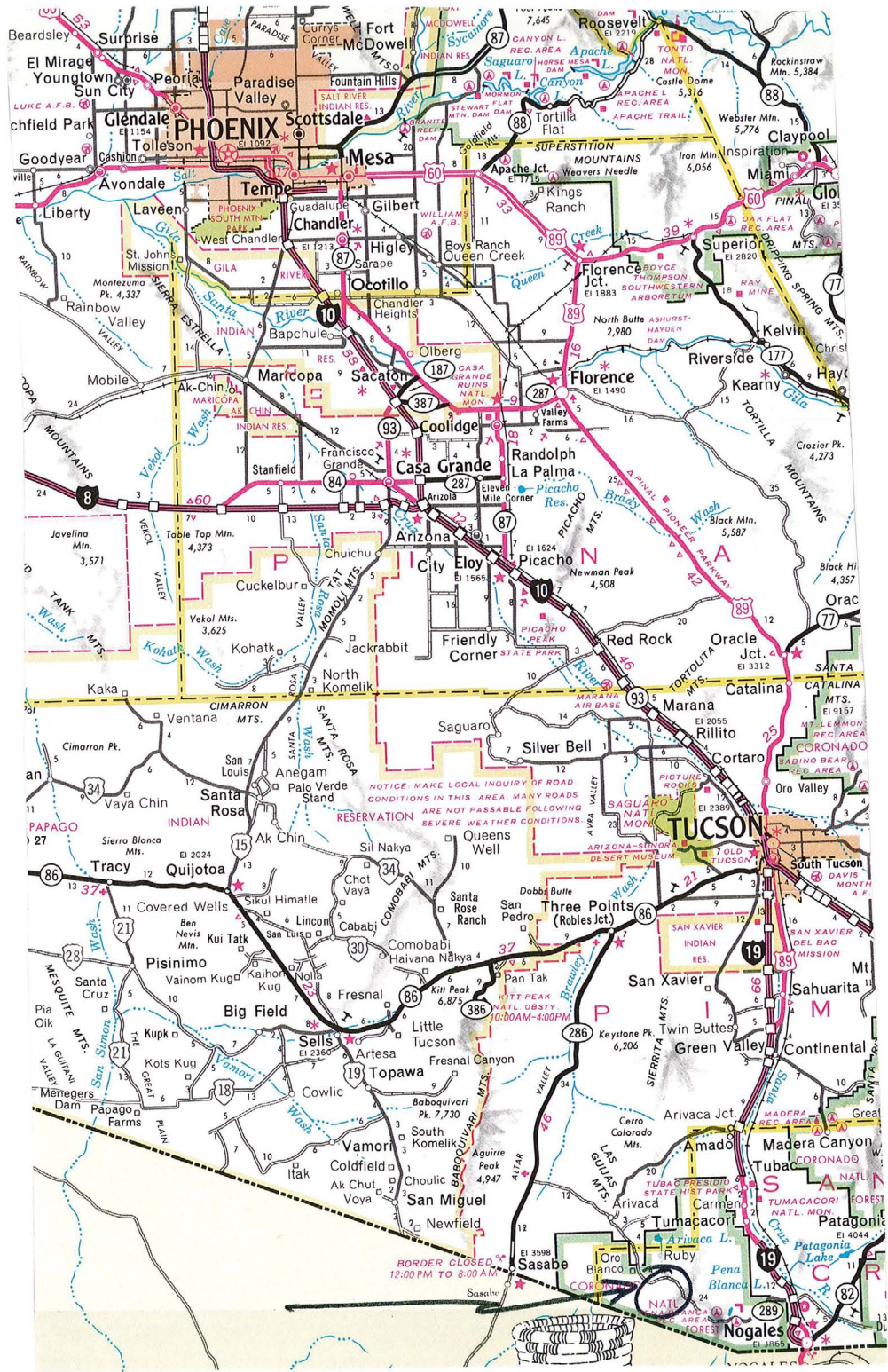
