MG WR 7/19/85: The Squaw Peak (Yavapai County) copper deposit, owned by Squaw Peak Copper, P O Box 69, Camp Verde, Arizona 86322, is covered chiefly by the Bonnie J claim group. The deposit is centered about Sec. 30, T13N R5E.

Interviewed Mrs. Thacker at Camp Verde. Visited the Squaw Peak mine which is under contract to Intermountain Exploration Co., Richard Wyman, Mgr. G. S. (Gill) Thatcher is diamond drilling on contract and was present at the time of visit. The drill crew consists of Stoos, driller, with Johnny Wyman (brother of Richard) as helper. A diamond drill hole is being put down in the main or upper adit at a point 500' from the portal. The hole is inclined downward at 65° in a southerly direction and drilling was at 200' depth. TPL WR 7-1-61

Visit to office - Dick Wyman who is directing exploratory drilling at the Squaw Peak mine. He reported the first drill hole bottomed at 250' showing good mineralization (not yet assayed) and hole No. 2 was drilling at 300'. TPL WR 7-22-61

Visited Mrs. Thacker at Camp Verde. Also visited her Squaw Peak mine. The property was idle. Intermountain Exploration Co. apparently is making an economic evaluation of the results from their recent drilling. No authentic data are available re these results. TPL WR 9-16-61

This property active Feb. 1962

Visited James Wingfield at Squaw Peak - no activity. FTJ WR 11-19-65

Learned that Gulf Oil had option on the Squaw Peak mine and did some drilling with more planned. FTJ WR 9-13-68

Phillips Petroleum were drilling the Squaw Peak mine - results not known. FTJ WR 4-11-69

Phillips Petroleum reported to be exploring Squaw Peak mine south of Camp Verde. FTJ QR 7-15-69

Interview with Mr. Wingfield re Squaw Peak mine - no activity. FTJ WR 9-12-69

To Camp Verde. Interviewed Mr. Wingfield's sister re Squaw Peak mine. Several geologists have been examining the deposit. FTJ WR 5-17-71

To Camp Verde. Visit with Wingfield at store regarding Squaw Peak mine. No activity since Phillips Petroleum ceased exploration. FTJ WR 8/16/72

MG WR 6/19/81: Mr. Bill Boler, Vice President, Squaw Peak Mining Co., Camp Verde, AZ, phone 567-9983 or at home 567-4170, says he is one of four owners of the Squaw Peak Copper Mine in Yavapai County. This property was drilled by Phillips Petroleum in 1969 and dropped. Some other company is now interested.

May 27, 1957

Visited Mrs. Thacker re Squaw Peak Mine. She reported that she optioned the property in April of this year to Rudy Gracey and William Savory. One man, Bob Stillman, is employed at present rehabilitating the camp etc. Rudy Gracey is proprietor of the Flagstaff Mineral Co., P.O. Box 1341, Flagstaff. For a time until recently he also represented Arizona Testing Laboratory in the Flagstaff area. TPL WR 7-31-59

Interviewed Mrs. Thacker at Camp Verde re activity at the Squaw Peak mine. As noted in my report for the week ending July 31 the property is leased to Rudy Gracey and William Savory, and one man is employed at the mine. Mrs. Thacker reports that the lessees have some substantial mining people interested. (Western Gold & Uranium) TPL WR 8-19-59

Visited Rudy Gracey - Flagstaff Minerals Co. - He said he and his partner had dropped their contract on Mrs. Thacker's Squaw Peak Mine. They had hoped to "turn it" to Western Gold & Uranium but that company did not want it, following an examination. TPL WR 9-19-59

Intermountain Exploration Company, P.O. Box 398, St. George, Utah have a lease and option on the Squaw Peak mine at Camp Verde. See letter from Richard V. Wyman, Pres. Intermountain Exploration Co. - Corres. file 10-15-60.

Visit with Mrs. Thacker

Mrs. Thacker reported that her Squaw Peak mine is under option to Intermountain Exploration Co., Richard V. Wyman, Pres., P.O. Box 398, St. George, Utah. Diamond drilling is being carried on at intermittent intervals. TPL Memo 9-29-60

Intermountain Exploration Co. is still investigating this property. Jack Howell is geologist. TPL WR 4-1-61

Visited Mrs. Thacker at Camp Verde. She reported that Intermountain Exploration Co. is drilling her Squaw Peak mine. Jack Howell is in charge with a 2 man crew. TPL WR 5-13-61














Location Map-Squaw Peak Mine Area
Yavapai County, Arizona






SQUAW PEAK MINE


