Subject: Field Engineers Report. Information from Isabel Repony, Christian Klosset and Jose Carrillo

Location: Approximately Sec. 10, T. 20 S., R. 15 E., about 1 to 1½ miles west of Onyx Cave. To reach property, drive north from Sonoita on Hwy. No. 82 for a distance of 4 miles. Turn left (west) on Gardner Canyon road and drive about 10 miles. Road is steep and narrow, and a jeep or 4 wheel drive is recommended.

Principal Minerals: Copper

Present Mining Activity: Driving an adit - 2 men working. Work was started about May 10th. There was an accident to two of the workers on May 13th. Operators are reported to plan on continuing operations.

Past History & Production: Mine was operated last September by other lessees and operators, who shipped 1 carload of ore to the smelter and shortly afterwards closed down operations. Field engineer tried to visit the property on Sept. 17, 1962, but had to turn back on account of bad roads.
