This occurrence was added to the ADMMR Industrial Minerals Addendum by Harrison Matson while employed by the ADMMR. The Tuff of Bear Springs Canyon is described by Medor H. Krieger in her geological maps of the Brandenburg Mtn. and the Holy Joe Peak quadrangles (U.S. Geological Survey GQ-668 and GQ-669 respectively). She does not specifically mention the local alteration to clinoptilolite, that being supplied by Harrison Matson's personal information. The location of C, Sec. 32, T6S, R18E was chosen arbitrarily for AZ MILS to locate the occurrence. The addition of dimension stone as a commodity is based on my personal communication with stone companies interested in the occurrence.
