

Location About 17 miles NE of Safford. Property lies NE of the Greater Arrowhead Group under option to Phelps Dodge Corp. and NW of the Lone Star Group undef option to Bear Creek Mining Co., and is reported to adjoin both groups.

Option to Purchase Bear Creek Mining Co. reported to have acquired an option to purchase the one half undivided interest of Strong and Harris; and the Phelps Dodge Corp. is reported to have acquired an option to purchase the one half undivided interest of W. D. Roper. These deals are reported to have been made approximately at the same time, before Strong and Harris and Mr. Roper had a chance to inform each others of the deals. It is now, evidently, up to Bear Creek Mining Co. and Phelps Dodge Corp. to come to some agreement as to which one will take the property over.

Subject: Field Engineers Report. Information from W. D. Roper and personal visits on Sept. 5, 1952, & on Feb. 7, 1957.

Location About 17 miles NE of Safford.

Number of Claims 7 unpatented claims.

Principal Minerals Copper ores, with some Gold and Silver.

Present Mining Activity None. Mine is idle.

Geology and Mineralization Veins contain copper ores. Narrow fissure veins in andesite. Some of these narrow Others are quartz veins containing Gold and Silver. On Sept. 5, 1952, the field engineer made an examination of the property at the request of Mr. Talley and Mr. Chesley, the owners, to determine the possibilities of Gold and Silver production. One typical fissure vein was examined. This vein was from one to two inches wide, containing quartz and broken materials from the footwall and hanging wall, the Gold values being found in the quartz. One sample, taken from a 1/2 ton lot of vein material assayed only \$ 1.40 per ton in Gold values. Possibilities of an underlying disseminated copper ore body was not being considered at the time of my visit on Sept. 5, 1952.

On Feb. 7, 1957, the field engineer again examined the property. At that time, the property was under lease to W. D. Roper and Strong and Harris. Mr. Moper was doing diamond drilling on the property, using a small diamond drill rig and Ex core. This drilling was done for the purpose of finding a copper ore deposit. At the time of my visit, the one drill hole, which they were drilling, was down to a depth of 70 ft. Mr. Roper did not report finding any ore.

On Apr. 4, 1957, it was reported that Rare Metals were negotiating for an option on the property. Mr. Roper states now that no agreement for an option was signed by Rare Metals.
