ZIRCON MINE

YAVAPAI COUNTY

Visited the Zircon Mine about 3/4 mile south of the Congress Mine. The property consists of the single Zircon claim and is under development by two partners, Carl Baker and a Mr. Rubash, both of Wickenburg (General Delivery). An incline shaft has been started on a thin gold quartz vein which strikes approximately E-W and dips about 25 northerly. The shaft is down about 30 feet and in the face shows a "feathering" of the narrow quartz seam upon which it was started. Occasional fine gold particles may be seen in specimens picked from the vein. Equipment consists of a compressor, slusher-hoist with bucket, also drilling equipment. These people also have an interest in the Topaz group of 3 claims located between the Zircon claim and the Ohio claim of the Congress property. Three men are employed.
