7. Comments:

(A) There is a deplorable lack of concrete evidence indicating specific amounts and values of ore in support of the application, which is understandable in view of a 50 year dormant period on this property. Such information as there is, although of an informal nature, is indicative of relatively high grade leadsilver ore in commercial quantities. On the basis of the included supporting statements of men who have witnessed or participated in mining operations on the property this lean is recommended.
