Unwater and rehabilitate 250 foot shaft and lateral workings therefrom, and sink shaft an additional 120 feet - \$5,000.00.

Applicants are owners by location.

7. Comments:

(A) Added to the docket are:

1. Report by A. C. Nebeker, Field Engineer, Department of Mineral Resources, dated January 12, 1943.

2. Memorandum by A. C. Nebeker, dated February 14, 1943.

3. Memorandum by J. S. Coupal, Director, Department of Mineral Resources, dated March 5, 1943.

(B) The ore bodies, three of them, have a very limited lateral length. Stopping from the 250 foot level up to the 70 foot level has only aggregated a production of 70 tons, or only 2.5 tons per foot of depth.

(C) Even the extreme high copper content of the more select ore fails to promise an interesting production in the light of the above limitations.

(D) The loan is not recommended. Application was previously made in October, 1942, which was likewise rejected.

F. W. Hatch, Dewey, Arizona, correspondent for Geo. B. McGarvey and F. W. Hatch.
2. Character of project and estimated cost thereof:  
Unwater and retimber mine workings and shaft to open up copper ores for sampling.
3. Location of property:  
Section 3 and 4, T 12 N., R. 2 E and Section 32 and 33, T 13 N, R. 2 E, 15 miles S. E. of Dewey, Yavapai County, Arizona.
4. Applicant's interest in or ownership of property:  
Geo. B. McGarvey and F. W. Hatch each own a one half interest in the 7 unpatented mining claims on which loan is requested.
5. Loan requested:  
A \$5,000 preliminary development loan is requested.
6. Loan recommended:  
No loan recommended.
7. Comments:  
(A) From the sketches 350 feet of shaft, 100 feet of raise and 850 feet of drifting has produced only 88 tons of ore. Evidently the ore shoot is a small high grade ore.  
  
(B) The shoot of high grade has apparently narrowed down to a stringer on the 250 foot level and whereas other showings are coming in, the unwatering will not expose ore which can be mined.  
  
(C) Additional development will be in the nature of exploration work.
