(2) The **Memoirs** (quarto series), established in 1895, are issued at irregular intervals. It is intended that each volume shall be devoted to monographs relating to some particular department of Science. Volume I is devoted to Astronomical Memoirs, Volume II to Zoölogical Memoirs, etc. The price is one dollar per part.

(3) The **Scientific Survey of Porto Rico and the Virgin Islands** (octavo series), established 1919, gives the detailed reports of the anthropological, botanical, geological, paleontological and zoölogical surveys of these islands.
