#### Mining Prospects in British Columbia and Alaska

Notes taken from conversation with D.B. Thurman - August 28, 1972

### British Columbia, Canada

- 1. HERB CLAIMS; Pb, Ag; 20 claims at Kassiar in northern British Columbia; \$127,000 exploration expense includes geochemistry, geophysics and 21 drill holes; high grade lead-silver veins 5 to 15 feet wide have been encountered.
- 2. CROY CLAIMS; Cu; 21 claims at Aiken Lake in north central B.C.; \$77,000 will be spent this year; 8 shallow drill holes totalling 3000 feet have encountered 2 to 10 foot intersections of 1 to 12% copper and induced polarization suggests greater potential at depth; 3 more holes are to be drilled to depth of 1000 feet this summer.
- 3. MISTY; Cu; 33 claims in Duckling Creek area adjacent to Kennecott's Laramie Creek property which is reported to contain 30 million tons of ore; geology and geochemistry looks encouraging.
- 4. TREAT CREEK; Cu; 67 claims on Jarvis Inlet 70 miles north of Vancouver; similar to Brittania Beach Mine; three shallow core holes with evidence of mineralization.

#### Alaska

- WHISTLE PIG; Pb, Zu, Cu, Ag; 296 claims plus 4 patented claims known as Ground Hog Basin claims reportedly contained 300,000 tons at 10% Pb, Zu located 20 miles east of Wrangell; \$150,000 spent, many shows of mineralization, 11 drill holes but no economic mineralization; Humble spent 1/2 million here.
- 2. SAN JUAN BAUTISTA; Cu, Mo; 60 claims on Prince of Wales Island west of Craig, Alaska; geologic work and good geochemical and geophysical anomalies; 7 drill holes up to 500 feet deep contain .02 to 1% copper.

- 3. PECOS; Pb, Ag, Cu; 6 claims in Hyder Mining district near Granduc.
- 4. TEXAS CREEK; Pb, Ag, Cu; 32 claims near Pecos with self potential and electro magnetic anomalies.
- 5. HETTA LAKE; Cu?; 53 claims on Prince of Wales Island with high geochemical value.
- 6. COPPER MOUNTAIN; Cu; 20 patented claims on Prince of Wales Island; USGS reports on this area; geology and geochemistry in progress.
