Gentlemen:

Pursuant to discussions between NICOR Mineral Ventures Inc. ("NICOR") and Santa Fe Mining Inc. ("Santa Fe") ("Party" or "Parties") covering certain properties within the Detrital Wash Valley, Mohave County, Arizona, which properties are more fully described in Exhibit A attached hereto, this letter ("Letter Agreement") sets forth the terms and conditions for an Exploration Joint Venture Agreement between the Parties.

When executed by the Parties, this Letter Agreement shall constitute a

binding agreement between NICOR and Santa Fe effective the \_\_\_\_ day of \_\_\_\_\_, 1985 (the "effective date") and shall terminate December 31, 1985 unless the Parties prepare and execute a formal joint venture agreement before that date. The joint venture agreement, which shall supersede this Letter Agreement shall be based upon Form 5, Mining Venture Agreement published by the Rocky Mountain Mineral Law Foundation and incorporate all of the terms set forth herein unless otherwise agreed upon by the Parties.

The parties agree as follows with respect to the Properties.

1. Grant; Title Confirmation

1.1 NICOR grants to Santa Fe an undivided one-half of NICOR's right, title and interest in and to the NICOR properties described on Exhibit A and Santa Fe grants to NICOR an undivided one-half of Santa Fe's right, title and interest in and to a rent free, royalty free lease covering the Santa Fe properties described in Exhibit A as well as a like interest in an additional 640 acre tract of Santa Fe property to be designated within \_\_\_\_ months from the date hereof.

1.2 The Parties agree promptly to deliver to each other copies of all title information pertaining to the Properties (including title opinion, abstracts, agreements, location certificates and the like) which it owns or to which it has access that establishes title to the Properties. The Parties shall have

fourteen (14) days after delivery of all such title information within which to notify each other that there is no objection to the other's title or that it has title objections, specifying such objections. If either of the Parties elects not to cure any such title objections and so notifies the other Party, this Letter Agreement will terminate and neither Party will have further rights or obligations hereunder, and neither Party will be entitled to reimbursement for expenditures which it may have made on or for the benefit of the Properties prior to the date of such termination.

1.3 Each Party warrants and represents to the other as follows with respect to its title to its Properties:

- (i) that its interests in its Properties are free and clear of liens, burdens, or claims of persons claiming by, through or under it;
- (ii) that it has no actual notice of conflicting claims or interests or of pending or threatened litigation relating to its Properties.

## II. Establishment of the Venture

Subject to the provision of Section I., above, NICOR and Santa Fe hereby establish a venture (the "Venture") to be effective upon acceptance by each Party of the record title to the Property, as

provided in Section 1, on the following terms and conditions.

## 2.1 Purposes

The purposes of the Venture will be to (i) drill one exploration drill hole at a location on the Properties that is acceptable to the Parties, which drill hole will penetrate to a sufficient depth to test a postulated borate bearing target horizon and (ii) as warranted the further exploration, development and commercial mineral exploitation of the Property.

## 2.2 Initial Contributions to the Venture

As initial property contributions to the Venture, NICOR and Santa Fe shall contribute the Properties described on Exhibit A and any and all data and information relating thereto.

As initial cash contributions to the Venture, NICOR and Santa Fe shall each contribute \$25,000.00 toward the estimated cost of \$50,000.00 to drill the exploration drill hole described in 2.1 (i).

## 2.3 Record Title to Venture Properties

Record interest of each Party in the Properties described in

Exhibit A or any other property acquired by either Party on behalf of the Venture shall remain in that Party until such time as the formal joint venture agreement supersedes this Letter Agreement. Upon execution of the formal joint venture agreement, each Party shall convey its record interest in Exhibit A Properties to the Venture Manager to be held in trust by the Manager as nominee for the Parties.

#### 2.4 Venture Management and Operation

Except as otherwise provided herein, after completion of the drill hole required in 2.1 (i) and a decision to proceed to activities contemplated under 2.1 (ii), the activities of the Venture will be directed by a Management Committee composed of two members appointed by each Party. Appointments may be made or changed by notice to the other party. Subject to due notice, a quorum will consist of committee members representing both parties. One member appointed by NICOR shall serve as chairman so long as NICOR's interest in the Venture is fifty percent (50%) or more, or if there are more than two parties to the Venture, as long as NICOR holds the greatest interest in the Venture. Except as otherwise provided herein, the Management Committee shall meet not less often than annually, but may meet more frequently as the parties may mutually agree, and may be required to meet not more than quarterly at the request of either party. In lieu of meetings, the Management Committee may hold telephone

conferences so long as all decisions are immediately confirmed in writing by the members of that committee.

Except as expressly provided herein to the contrary, the Management Committee shall be responsible for the direction and supervision of the Venture's activities, including adoption of programs and budgets for commercial development; determining the nature, extent and timing of development and production operations on the Property; determining third-party participation, if any (with any such participation which dilutes the interests of all parties to be subject to unanimous approval); and determining the nature, extent and terms of any borrowings for use in Venture activities and use of the Property as collateral therefor. The Management Committee shall not have any authority to direct the drilling of the drill hole required under 2.1 (i) which NICOR shall manage in its sole discretion.

Management Committee voting rights shall be proportional to the share each party has in the Venture and may be exercised by either member of the Management Committee appointed by a party. The majority vote shall rule. If a majority vote is not obtained on a proposed program and budget: (i) the Manager will be authorized to conduct such operations as are necessary to preserve the Property until a program and budget is adopted and (ii) for a period of 60 days after the Management Committee meetings at which such deadlock occurred,

each party will be entitled to submit an alternative program and budget for the period covered by the proposal on which the deadlock has occurred. If the Management Committee remains unable to adopt a program and budget, either party may offer in writing to sell its interest at a specified cash price to the other party. The noticed party will then have thirty (30) days in which to elect by written notice to the offering party to purchase the interest or to sell its own interest to the offering party at the specified cash price. Failure to make a timely election to sell shall be deemed an election to purchase. An election by the noticed party to sell its interest shall be deemed an offer accepted by the offering party without further action.

NICOR will serve as the Manager of the Venture and shall have the right to so serve as long as it holds at least a fifty percent (50%) interest in the Venture or, if there are more than two parties to the Venture, as long as NICOR holds the greatest interest in the Venture. The Manager will be solely responsible for the management and control of all Venture activities and operations, subject to the supervision of the Management Committee. The Manager of the Venture will maintain and preserve the Property and will implement all work programs and projects adopted by the Management Committee. The Manager's sole obligations to the non-managing party shall be (i) to act in a commercially reasonable manner, (ii) to act in good faith to comply with the directions of the Management

Committee and (iii) to comply with applicable laws, rules and regulations.

The Manager of the Venture will be entitled to reimbursement for its actual and reasonable expenses for overhead and administration services associated with the Venture's activities.

In case of emergency, the Manager may take any action it deems reasonably necessary to protect life, limb or property, or to comply with law or governmental regulation. The Manager shall also maintain reasonable insurance coverage and will cause work in good faith intended to satisfy annual assessment work requirements on the Property to be carried out in a timely manner and all necessary filings to be made in connection therewith.

2.5 Dilution of Interests in the Venture

A timely election not to contribute at any time shall preclude the electing party from contributing to the Venture until the electing party's fifty percent (50%) interest in the Property and the Venture has been diluted to a thirty percent (30%) interest. The Manager shall promptly notify the noncontributing party when that party's interest has been diluted to a thirty percent (30%) interest. The noncontributing party will have thirty (30) days from receipt

of such notice to elect whether or not to contribute its thirty percent (30%) share of future Venture costs, and if it so elects not to contribute, it will again be precluded from contributing to the Venture until its interest has been diluted to fifteen percent (15%). The Manager shall promptly notify the noncontributing party when that party's interest has been diluted from a thirty percent (30%) interest to a fifteen percent (15%) interest, and the noncontributing party shall have thirty (30) days from receipt of such notice to elect whether or not to contribute its fifteen percent (15%) share of future Venture costs, and if it so elects not to contribute, its interest shall convert to a 10% Net Proceeds interest, as that term is defined in Exhibit D to Form 5, Mining Ventures Agreement, that party shall become a "Net Proceeds Interest Owner" and the Venture will terminate. A failure to give timely notice of the election to contribute will constitute an election to be diluted.

## 2.6 Allocation and Distribution of Net Proceeds

Any party may elect to receive its share of Venture production in kind in minerals recovered in Venture operations, but such party shall alone bear any increased costs to the Venture in so delivering such products in kind.

Subject to the rights of parties to take production in kind, net proceeds of Venture operations shall be allocated to the

parties in proportion to their Venture interests.

Proceeds from Venture operations will be distributed to the parties from time to time when reasonably determined by the Manager to be available for distribution. The Manager agrees to review the status of Venture revenues and expenses not less often than quarterly after commercial production has commenced and, if possible, to distribute all accumulated revenues which exceed reasonably anticipated expenses for the following quarter.

#### 2.7 Term and Termination of Venture

The Venture will remain in effect until the first to occur of the following:

- (i) the mutual agreement of the parties to terminate Venture;
- (ii) termination of the Venture's interests in all of the Property;
- (iii) at the written election of a nondefaulting party upon the material default hereunder by the other party which the defaulting party fails to remedy within thirty (30) days after notice thereof from the electing party.

Either party may relinquish its interest in any portion of the Property at any time by not less than thirty days' notice to the other party. Such relinquished portion shall be excluded from the Venture, but the Venture shall continue to govern the remainder of the Property. The party relinquishing any such interest shall quitclaim the interest to the other party on request.

2.8 Area of Mutual Interest

The parties to the Venture will be subject to an area of mutual interest covering all lands within one (1) mile of any portion of the Property.

2.9 Preferential Purchase Right

If any party desires to sell or transfer (other than in connection with a merger or consolidation or transfer to a parent or wholly-owned subsidiary) its interest in the Venture: (i) any such interest shall not be subdivided but shall be sold or transferred in its entirety only to a single purchaser or transferee, provided, however, that each party may, on one occasion, transfer a portion of its interest (but in all events not less than a 10% interest in the Venture) to a third party subject to this Paragraph 2.9 and (ii) the party desiring to sell or transfer its interest must first give the other party the opportunity to purchase that interest. The

other party shall have 60 days from receipt of notice of such opportunity to elect to purchase the interest. Failure to timely notify the transferring party of an election to purchase shall be deemed an election not to purchase. If the other party declines to purchase the interest, the transferring party may then sell or transfer its interest to any third party at a price not less than that offered to the other party.

## 2.10 Relationship of the Parties

The liabilities of the parties shall be several and individual, not joint. Neither party shall be liable for the expenses, costs or liabilities of the other party, unless expressly provided to the contrary herein.

## 2.11 Access

Subject to reasonable prior notice to the Manager, either party shall have full and free access to the Property, all Venture operations thereon or related thereto, and to all data, books and records gathered or maintained by the Manager with respect thereto.

## 2.12 Encumbrances

Neither party will create or suffer a lien or encumbrance on

its interest in the Venture or the Property except as permitted in Paragraph 2.4 above.

### 3.0 General Provisions

#### 3.1 Notices

Notices and deliveries of information will be in writing and effective upon receipt after transmission by United States mail, postage prepaid, addressed to the parties at the addresses set forth above.

#### 3.2 Confidentiality

Information regarding this Agreement, the Venture, the Property and operations of the parties on or with respect to the Property is confidential and will not be disclosed to third parties without the prior consent of the nondisclosing party, which consent will not be withheld unreasonably, except that a party may disclose such information without first obtaining the other party's consent if the disclosure is:

- (i) to consultants, contractors and potential participants in the project;
- (ii) to potential purchasers or providers of funding for the project; or

(iii) required by law or by the rules of any applicable stock exchange.

In connection with any disclosure, the disclosing party shall take reasonable steps to notify the other party in advance of the disclosure and to preserve the confidentiality of the information disclosed.

### 3.3 Representations and Warranties

Each party expressly represents and warrants to the other party that: (a) it has all the requisite power and authority to enter into this Agreement and to perform its obligations hereunder; (b) it has taken all the necessary action to authorize the execution and delivery of this Agreement and the performance of all its obligations hereunder; (c) it is not a party to nor bound by any agreement or instrument of any kind, or any pending or threatened action, suit, claim or proceeding, or any judgment, order, writ or injunction of any court or governmental body that would prohibit or adversely affect the performance of its obligations hereunder.

### 3.4 Successors and Assigns

This Agreement is binding on the permitted successors and assigns of the parties hereto. No assignment hereof will be

effective until the assignee has agreed in writing to the terms hereof, and such agreement has been delivered to the non-assigning party. No such assignment shall relieve the assigning party of its obligations hereunder unless the non-assigning party so consents in writing.

### 3.5 Force Majeure

The obligations of either party hereunder, except the obligation to pay or contribute funds, will be suspended and the time for performance extended where such performance is prevented or made impracticable by events, occurrences or laws beyond such party's control.
